A BILL

To establish the Harriet Tubman National Historical Park in Auburn, New York, and the Harriet Tubman Underground Railroad National Historical Park in Caroline, Dorchester, and Talbot Counties, Maryland, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Harriet Tubman Na-
- 5 tional Historical Park and Harriet Tubman Underground
- 6 Railroad National Historical Park Act".

1 SEC. 2. FINDINGS; PURPOSES. 2 (a) FINDINGS.—Congress finds that— 3 (1) Harriet Tubman (born Araminta "Minty" 4 Ross)— 5 (A) was born into slavery in Maryland 6 around 1822; 7 (B) married John Tubman at age 25; 8 (C) endured through her youth and young 9 adulthood the hardships of enslaved African-Americans; and 10 11 (D) boldly emancipated herself from bond-12 age in 1849; 13 (2) not satisfied with attaining her own free-14 dom, Harriet Tubman— 15 (A) returned repeatedly for more than 10 16 years to the places of her enslavement in Dor-17 chester and Caroline Counties, Maryland; and 18 (B) under the most adverse circumstances 19 led away many family members and acquaint-20 ances to freedom in the northern region of the 21 United States and Canada; 22 (3) Harriet Tubman was— (A) called "Moses" by African-Americans 23

and white abolitionists; and

1	(B) acknowledged as 1 of the most promi-
2	nent "conductors" of the resistance that came
3	to be known as the "Underground Railroad";
4	(4) in 1868, Frederick Douglass wrote that,
5	with the exception of John Brown, Douglass knew of
6	"no one who has willingly encountered more perils
7	and hardships to serve our enslaved people" than
8	Harriet Tubman;
9	(5) during the Civil War, Harriet Tubman—
10	(A) was recruited to assist Union troops as
11	a nurse, a scout, and a spy; and
12	(B) served in Virginia, Florida, and South
13	Carolina, where she is credited with facilitating
14	the rescue of hundreds of enslaved people;
15	(6) Harriet Tubman established in Auburn,
16	New York, 1 of the first incorporated homes for
17	aged African-Americans in the United States, which,
18	10 years before her death, she bequeathed to the Af-
19	rican Methodist Episcopal Zion Church;
20	(7) there are nationally significant resources
21	comprised of relatively unchanged landscapes associ-
22	ated with the early life of Harriet Tubman in Caro-
23	line, Dorchester, and Talbot Counties, Maryland;

1	(8) there are nationally significant resources re-
2	lating to Harriet Tubman in Auburn, New York, in-
3	cluding—
4	(A) the residence of Harriet Tubman;
5	(B) the Tubman Home for the Aged;
6	(C) the Thompson Memorial AME Zion
7	Church; and
8	(D) the final resting place of Harriet Tub-
9	man in Fort Hill Cemetery;
10	(9) in developing interpretive programs, the Na-
11	tional Park Service would benefit from increased
12	scholarship of the African-American experience dur-
13	ing the decades preceding the Civil War and
14	throughout the remainder of the 19th century; and
15	(10) it is fitting and proper that the nationally
16	significant resources relating to Harriet Tubman be
17	preserved for future generations as units of the Na-
18	tional Park System so that people may understand
19	and appreciate the contributions of Harriet Tubman
20	to the history and culture of the United States.
21	(b) Purposes.—The purposes of this Act are—
22	(1) to preserve and promote stewardship of the
23	resources in Auburn, New York, and Caroline, Dor-
24	chester, and Talbot Counties, Maryland, relating to
25	the life and contributions of Harriet Tubman;

- 1 (2) to provide for partnerships with the African 2 Methodist Episcopal Zion Church, the States of New 3 York and Maryland, political subdivisions of the States, the Federal Government, local governments, 5 nonprofit organizations, and private property owners 6 for resource protection, research, interpretation, edu-7 cation, and public understanding and appreciation of 8 the life and contributions of Harriet Tubman; 9 (3) to sustain agricultural and forestry land 10 uses in Caroline, Dorchester, and Talbot Counties, 11 Maryland, that remain evocative of the landscape 12 during the life of Harriet Tubman; and 13 (4) to establish a competitive grants program 14 for scholars of African-American history relating to 15 Harriet Tubman and the Underground Railroad. 16 SEC. 3. DEFINITIONS. 17 In this Act: 18 (1) CHURCH.—The term "Church" means the 19 Thompson Memorial AME Zion Church located in 20 Auburn, New York. 21
 - (2) Historically black college or uni-VERSITY.—The term "historically Black college or university" has the meaning given the term "part B institution" in section 322 of the Higher Education Act of 1965 (20 U.S.C. 1061)).

13	(e) Interpretation.—The Secretary may provide

19	ical Park.
20	(c) Acquisition of Land.—The Secretary may ac-
21	quire from willing sellers, by donation, purchase with do-
22	nated or appropriated funds, or exchange, land or an in-
23	terest in land within the boundaries of the Historical
24	Park.

- (d) Grants.—In accordance with section 7(b)(2), the
 Secretary may provide grants—
- (1) to the State of Maryland, political subdivisions of the State, and nonprofit organizations for the acquisition of less than fee title (including easements) or fee title to land in Caroline, Dorchester, and Talbot Counties, Maryland, within the boundary of the Historical Park; and
- 9 (2) on execution of a memorandum of under-10 standing between the State of Maryland and the Di-11 rector of the National Park Service, to the State of 12 Maryland for the construction of the Harriet Tub-13 man Underground Railroad State Park Visitor Cen-14 ter on land owned by the State of Maryland in Dor-15 chester County, Maryland, subject to the condition 16 that the State of Maryland provide the Director of 17 the National Park Service, at no additional cost, suf-18 ficient office space and exhibition areas in the Vis-19 itor Center to carry out the purposes of the Histor-20 ical Park.
- 21 (e) FINANCIAL ASSISTANCE.—The Secretary may 22 provide grants to, and enter into cooperative agreements 23 with, the State of Maryland, political subdivisions of the 24 State, nonprofit organizations, colleges and universities, 25 and private property owners for—

1	(1) the restoration or rehabilitation, public use,
2	and interpretation of sites and resources relating to
3	Harriet Tubman;
4	(2) the conduct of research, including archae-
5	ological research;
6	(3) providing stewardship programs, education,
7	signage, and other interpretive devices at the sites
8	and resources for interpretive purposes; and
9	(4)(A) the design and construction of the Vis-
10	itor Center; and
11	(B) the operation and maintenance of the Vis-
12	itor Center.
13	(f) Interpretation.—The Secretary may provide
14	interpretive tours to sites and resources located outside
15	the boundary of the Historical Park in Caroline, Dor-
16	chester, and Talbot Counties, Maryland, relating to the
17	life of Harriet Tubman and the Underground Railroad.
18	(g) General Management Plan.—
19	(1) In general.—Not later than 3 years after
20	the date on which funds are made available to carry
21	out this subsection, the Secretary, in coordination
22	with the State of Maryland, political subdivisions of
23	the State, and the United States Fish and Wildlife
24	Service, shall complete a general management plan

1	for the Historical Park in accordance with section
2	12(b) of Public Law 91–383 (16 U.S.C. 1a–7(b)).
3	(2) Coordination.—The Secretary shall co-
4	ordinate the preparation and implementation of the
5	general management plan for the Historical Park
6	with—
7	(A) the Harriet Tubman National Histor-
8	ical Park in Auburn, New York;
9	(B) the National Underground Railroad:
10	Network to Freedom;
11	(C) the Maryland Harriet Tubman Under-
12	ground Railroad State Park; and
13	(D) the Harriet Tubman Underground
14	Railroad Byway in Dorchester and Caroline
15	Counties, Maryland.
16	(3) Priority treatment.—The general man-
17	agement plan for the Historical Park shall give pri-
18	ority to the adequate protection of, interpretation of,
19	public appreciation for, archaeological investigation
20	of, and research on Stewart's Canal, the Jacob
21	Jackson home site, the Brodess Farm, the Ben Ross
22	and Anthony Thompson properties on Harrisville
23	Road, and the James Cook site, all of which are pri-
24	vately owned potential future properties in the
25	Blackwater National Wildlife Refuge.

1	(h) Blackwater National Wildlife Refuge.—
2	(1) Interagency agreement.—The Secretary
3	shall ensure that, not later than 1 year after the
4	date of enactment of this Act, the National Park
5	Service and the United States Fish and Wildlife
6	Service enter into an interagency agreement that—
7	(A) promotes and mutually supports the
8	compatible stewardship and interpretation of
9	Harriet Tubman resources at the Blackwater
10	National Wildlife Refuge; and
11	(B) provides for the maximum level of co-
12	operation between those Federal agencies to
13	further the purposes of this Act.
14	(2) Effect of act.—Nothing in this Act
15	modifies, alters, or amends the authorities of the
16	United States Fish and Wildlife Service in the ad-
17	ministration and management of the Blackwater Na-
18	tional Wildlife Refuge.
19	SEC. 6. ADMINISTRATION.
20	(a) In General.—The Secretary shall administer
21	the Harriet Tubman National Historical Park and the
22	Harriet Tubman Underground Railroad National Histor-
23	ical Park in accordance with this Act and the laws gen-
24	erally applicable to units of the National Park System in-
25	cluding—

1	(1) the National Park Service Organic Act (16
2	U.S.C. 1 et seq.); and
3	(2) the Act of August 21, 1935 (16 U.S.C. 461
4	et seq.).
5	(b) Park Regulations.—Notwithstanding sub-
6	section (a), regulations and policies applicable to units of
7	the National Park System shall apply only to Federal land
8	administrated by the National Park Service that is located
9	within the boundary of the Harriet Tubman Underground
10	Railroad National Historical Park.
11	SEC. 7. AUTHORIZATION OF APPROPRIATIONS.
12	(a) In General.—There are authorized to be appro-
13	priated such sums as are necessary to carry out this Act
14	(other than subsection (b)), including the provision of Na-
15	tional Park Service personnel and National Park Service
16	management funds for the Harriet Tubman National His-
17	torical Park and the Harriet Tubman Underground Rail-
18	road National Historical Park.
19	(b) Grants.—There are authorized to be appro-
20	priated not more than—
21	(1) \$7,500,000 to provide grants to the Church
22	for—
23	(A) historic preservation, rehabilitation,
24	and restoration of resources within the bound-

1	ary of the Harriet Tubman National Historical
2	Park; and
3	(B) the costs of design, construction, in-
4	stallation, and maintenance of exhibits and
5	other interpretive devices authorized under sec-
6	tion $4(d)(1)(B)$;
7	(2) \$11,000,000 for grants to the State of
8	Maryland for activities authorized under subsections
9	(d)(1) and $(e)(4)(A)$ of section 5; and
10	(3) \$200,000 for fiscal year 2009 and each fis-
11	cal year thereafter for competitive grants to histori-
12	cally Black colleges and universities, Predominately
13	Black Institutions, and minority serving institutions
14	for research into the life of Harriet Tubman and the
15	African-American experience during the years that
16	coincide with the life of Harriet Tubman.
17	(c) Cost-Sharing Requirement.—
18	(1) Church and visitor center grants.—
19	The Federal share of the cost of activities provided
20	grants under paragraph (1) or (2) of subsection (b)
21	and any maintenance, construction, or utility costs
22	incurred pursuant to a cooperative agreement en-
23	tered into under section 4(d)(1)(A) or section 5(e)

shall not be more than 50 percent.

1	(2) Historically black colleges and uni-
2	VERSITIES.—The Federal share of the cost of activi-
3	ties provided assistance under subsection (b)(3) shall
4	be not more than 75 percent.
5	(3) Form of non-federal share.—The non-

(3) FORM OF NON-FEDERAL SHARE.—The non-Federal share required under this subsection may be in the form of in-kind contributions of goods or services fairly valued.
