A BILL

To amend title 38, United States Code, to improve the outreach activities of the Department of Veterans Affairs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Outreach Im-
- 5 provement Act of 2007".
- 6 SEC. 2. IMPROVEMENT OF OUTREACH ACTIVITIES WITHIN
- 7 DEPARTMENT OF VETERANS AFFAIRS.
- 8 (a) In General.—Chapter 5 of title 38, United
- 9 States Code, is amended by adding at the end the fol-
- 10 lowing new subchapter:

| 4 | "(a) The Secretary shall establish and maintain pro- |

| 9 | "(2) The Office of Public Affairs. |
| 10 | "(3) The Veterans Health Administration. |

| 13 | "(b) The Secretary shall— |
| 14 | "(1) annually review the procedures in effect |
| 15 | under subsection (a) for the purpose of ensuring |
| 16 | that those procedures meet the requirements of that |
| 17 | subsection; and |
| 18 | "(2) make such modifications to those proce- |
| 19 | dures as the Secretary considers appropriate in light |
| 20 | of such review in order to better achieve that pur- |
| 21 | pose. |

| 4 | "(a) It is the purpose of this section to provide for |
| 5 | assistance by the Secretary to the States in carrying out |
| 6 | programs within their respective jurisdiction that offer a |
| 7 | high probability of improving outreach and assistance to |
| 8 | veterans, and to the spouses, children, and parents of vet- |
| 9 | erans, so as to ensure that such individuals are fully in- |
| 10 | formed about, and assisted in applying for, any veterans' |
| 11 | and veterans-related benefits and programs (including |
| 12 | State veterans' programs) for which they may be eligible. |
| 13 | "(b) The Secretary shall ensure that, as a condition |
| 14 | of the provision of assistance by the Secretary under this |
| 15 | section, that such assistance is provided for outreach and |
| 16 | assistance under State and county veteran service pro- |
| 17 | grams referred to in subsection (a) in locations— |
| 18 | "(1) that have relatively large concentrations of |
| 19 | populations of veterans and other individuals re- |
| 20 | ferred to in subsection (a); or |
| 21 | "(2) that are experiencing growth in the popu- |
| 22 | lation of veterans and other individuals referred to |
| 23 | in subsection (a). |
| 24 | "(c) The Secretary may enter into cooperative agree- |
| 25 | ments and arrangements with State veterans agencies in |
| 26 | order to carry out, coordinate, improve, or otherwise en- |

- 1 hance outreach by the Department and the States (includ-
- 2 ing outreach with respect to State veterans' programs).
- 3 "(d)(1) The Secretary may make grants to State vet-
- 4 erans agencies in order to achieve the following purposes:
- 5 "(A) To carry out, coordinate, improve, or oth-
- 6 erwise enhance outreach, including activities pursu-
- 7 ant to cooperative agreements and arrangements
- 8 under subsection (c).
- 9 "(B) To carry out, coordinate, improve, or oth-
- erwise enhance activities to assist in the development
- and submittal of claims for veterans' and veterans-
- related benefits, including activities pursuant to co-
- operative agreements and arrangements under sub-
- section (c).
- 15 "(2) A State veterans agency receiving a grant under
- 16 this subsection shall use the grant amount for purposes
- 17 described in paragraph (1) by—
- 18 "(A) awarding a portion of such grant amount
- to local governments of that State that provide vet-
- erans outreach services, to be awarded on the basis
- of the number of veterans residing in the jurisdiction
- of that local government;
- 23 "(B) awarding a portion of such grant amount
- to local governments in that State seeking to estab-
- lish a program of outreach services; and

- 1 "(C) using the remainder for outreach activities
- 2 of that State veterans agency.
- 3 "(3) No portion of the amount of a grant to a State
- 4 under this subsection may be used at the State level for
- 5 the purpose of administering those funds.
- 6 "(4) Federal funds provided to a State by a grant
- 7 under this subsection may not be used to provide more
- 8 than 50 percent of the total cost of such State and local
- 9 government activities and shall be used to expand existing
- 10 outreach programs and services, not to supplant existing
- 11 State and local funding. The Secretary shall allocate funds
- 12 to the States for grants under this subsection on the basis
- 13 of the veteran population of the respective States.
- 14 "(5)(A) In a case in which a unit of local government
- 15 does not have a veteran services program, funds from a
- 16 grant under this subsection may be used to establish such
- 17 a program.
- 18 "(B) In a case in which a unit of local government
- 19 does not have such a program and does not seek to estab-
- 20 lish such a program through assistance from a grant
- 21 amount under this subsection, the State veterans agency
- 22 may use funds available under this subsection to provide
- 23 outreach services for that local government jurisdiction.
- 24 "(C) In the case of a State in which State and local
- 25 government veteran service programs do not seek to re-

- 1 ceive a grant amount under this subsection, the funds for
- 2 that State shall be reallocated to those States in which
- 3 local government veteran service programs exist and have
- 4 chosen to seek to receive a grant amount under this sub-
- 5 section.
- 6 "(6) Funds made available through a grant under
- 7 this subsection may be used for education and training
- 8 for State and local government employees who provide (or
- 9 when trained will provide) veterans outreach services in
- 10 order for those employees to obtain accreditation in ac-
- 11 cordance with procedures approved by the Secretary and,
- 12 for employees so accredited, for purposes of continuing
- 13 education.
- 14 "(7) In this subsection, the term 'State veterans
- 15 agency' means the element of the government of a State
- 16 that has responsibility for programs and activities of that
- 17 State government relating to veterans benefits.

18 "§ 563. Outreach activities: funding

- 19 "(a) Amounts for the outreach activities of the De-
- 20 partment under this subchapter shall be budgeted and ap-
- 21 propriated through a separate appropriation account.
- 22 "(b) In the budget justification materials submitted
- 23 to Congress in support of the Department budget for any
- 24 fiscal year (as submitted with the budget of the President
- 25 under section 1105(a) of title 31), the Secretary shall in-

- 1 clude a separate statement of the amount requested to be
- 2 appropriated for that fiscal year for the account specified
- 3 in subsection (a).

4 "§ 564. Definition of outreach

- 5 "For purposes of this subchapter, the term 'outreach'
- 6 means the act or process of taking steps in a systematic
- 7 manner to provide information, services, and benefits
- 8 counseling to veterans, and the survivors of veterans, who
- 9 may be eligible to receive benefits under the laws adminis-
- 10 tered by the Secretary to ensure that those individuals are
- 11 fully informed about, and assisted in applying for, any
- 12 benefits and programs under such laws for which they may
- 13 be eligible.

14 "§ 565. Authorization of appropriations

- 15 "There are authorized to be appropriated to the Sec-
- 16 retary for the purposes of carrying out this subchapter,
- 17 including the making of grants under section 562(d) of
- 18 this title, the amount of \$25,000,000 for each of fiscal
- 19 years 2007, 2008, and 2009.".
- 20 (b) CLERICAL AMENDMENT.—The table of sections
- 21 at the beginning of such chapter is amended by adding
- 22 at the end the following new items:

"SUBCHAPTER IV—OUTREACH ACTIVITIES

- "561. Outreach activities: coordination of activities within the Department.
- "562. Outreach activities: cooperative activities with States; grants to States for improvement of outreach.
- "563. Outreach activities: funding.

"564. Definition of outreach.

"565. Authorization of appropriations.".
