A BILL

To impose requirements with regard to border searches of digital electronic devices and digital storage media, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Securing Our Borders
- 5 and Our Data Act of 2008".

SEC. 2. BORDER SEARCHES AND SEIZURES RELATING TO

- 3 (a) Fundamental Rules.—The following rules
- 4 shall apply to any border search or seizure relating to a

- 7 (1) Except as otherwise provided in this sub8 section, no search of the digital contents of the de9 vice or media may be based on the power of the
 10 United States to search a person and that person's
 11 possessions upon entry into the United States, un12 less that search is based on a reasonable suspicion
 - (2) No seizure of the digital contents of a device or media, or of the device or media itself, may be based on the power of the United States to search a person and that person's possessions upon entry into the United States, but must be based on some other constitutional authority to make the seizure.
 - (3) Any search of the digital contents of a device or media must be conducted only by officers who have received appropriate training, in order to minimize the possibility of irreparable damage to, or erasure of, files and the hardware itself, and must be conducted in the presence of a supervisor. At the

1	request of the traveler, such search shall be con-
2	ducted out of public view.
3	(4) An individual may be required to turn or
4	the device in order to demonstrate it is a working
5	device.
6	(b) Supplemental and Implementing Rules by
7	SECRETARY OF HOMELAND SECURITY.—The Secretary of
8	Homeland Security shall—
9	(1) make rules regarding border searches to
10	which subsection (a) applies, detailing—
11	(A) policies for protecting the integrity of
12	the data;
13	(B) policies for the length of time seized
14	data will be stored and where and how it wil
15	be stored;
16	(C) policies for whether the downloaded in-
17	formation will be shared and, if so, with what
18	other governmental entities and under what cir-
19	cumstances;
20	(D) information as to what rights an indi-
21	vidual has to ensure that individual's device or
22	media is returned; and
23	(E) a requirement that a receipt be given
24	immediately to anyone whose device or media is

1	seized with information regarding whom to call
2	for information about the seizure; and
3	(2) place these rules on the Department of
4	Homeland Security website in a manner that makes
5	them readily publicly available.
6	(c) Definitions.—In this section—
7	(1) the term "border search" means any search
8	of an individual upon entry into the United States
9	based on the power of the United States to search
10	a person and that person's possessions upon entry to
11	the United States;
12	(2) the term "digital electronic device" means
13	any electronic device that contains digital data, in-
14	cluding laptops, personal digital assistants, wireless
15	phones, iPods, iPhones, BlackBerrys, and digital
16	cameras; and
17	(3) the term "digital storage media" means any
18	memory device that contains or may contain digital
19	data.
20	SEC. 3. ANNUAL STUDY AND REPORT ON SEARCHES AND
21	SEIZURES OF TRAVELERS BY THE UNITED
22	STATES CUSTOMS SERVICE.
23	(a) Study.—The Commissioner of the United States
24	Customs Service shall conduct an annual study of searches
25	and seizures, during the prior year, of the digital contents

- 1 of digital electronic devices and digital storage media, and
- 2 of seizures of such devices and media, that are based on
- 3 the power of the United States to search or seize a person
- 4 and that person's possessions upon entry into the United
- 5 States. The study shall include the number of such
- 6 searches and seizures, the race, gender, and national ori-
- 7 gin of the travelers subject to those searches, the type of
- 8 searches conducted, and the results of the searches.
- 9 (b) Report.—Not later than March 31 of each year,
- 10 the Commissioner of the Customs Service shall submit to
- 11 the Congress the annual report containing the results of
- 12 the study conducted under subsection (a) for the prior
- 13 year.
