Mr. KUCINICH introduced the following bill; which was referred to the
Committee on Transportation and Infrastructure

A BILL

To affirm that exports and diversions of water from the Great Lakes may only be approved if such exports and diversions are in the public interest, to provide for enforcement, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROTECTING WATER RESOURCES IN THE**
4 **GREAT LAKES.**

5 (a) AMENDMENTS TO FINDINGS.—Section 1109(a) of
6 the Water Resources Development Act of 1986 (42 U.S.C.
7 1962d–20(a)) is amended—

1 (1) in paragraph (1) by striking “the Great
2 Lakes are a most important natural resource” and
3 inserting “the Great Lakes and the waters of the
4 Great Lakes Basin are impressed with a public trust
5 and are critical”;

6 (2) by redesignating paragraphs (2) through
7 (4) as paragraphs (3) through (5); and

8 (3) by inserting after paragraph (1) the fol-
9 lowing:

10 “(2) the Great Lakes, their connecting waters,
11 tributary streams, lakes, and groundwater are a sin-
12 gle hydrologic system which must be protected, con-
13 served, and maintained as a whole;”.

14 (b) AMENDMENTS TO PURPOSE AND POLICY.—Sec-
15 tion 1109(b) of such Act (42 U.S.C. 1962d–20(b)) is
16 amended—

17 (1) in paragraph (2) by striking “water con-
18 servation and” and inserting “water conservation,
19 public trust, maintaining flows and levels of navi-
20 gable waters, and water”;

21 (2) in paragraph (3)—

22 (A) by striking “diversion” both places it
23 appears and inserting “diversion or export”;

24 and

1 (B) by striking “; and” and inserting “in
2 accordance and consistent with the mechanism,
3 standard, and principles described in paragraph
4 (2);”;

5 (3) in paragraph (4) by striking the period at
6 the end and inserting “; and”; and

7 (4) by adding at the end the following:

8 “(5) to provide for the enforcement of the pro-
9 hibitions and requirements of this section.”.

10 (c) OTHER TECHNICAL AND CONFORMING AMEND-
11 MENTS.—Section 1109(d) of such Act (42 U.S.C. 1962d–
12 20(d)) is amended—

13 (1) by striking “tributary” and inserting “trib-
14 utary, including tributary groundwater,”; and

15 (2) by striking the period at the end and insert-
16 ing “in accordance and consistent with the mecha-
17 nism, standard, and principles described in sub-
18 section (b)(2).”

19 (d) CIVIL SUIT PROVISION.—Section 1109 of such
20 Act (42 U.S.C. 1962d–20) is amended—

21 (1) by redesignating subparagraph (f) as sub-
22 paragraph (g); and

23 (2) by inserting after subparagraph (e) the fol-
24 lowing:

1 “(f) The prohibition on any diversion or export of
2 water under subsection (d) may be enforced through a civil
3 suit filed by the Federal Government, a State or local gov-
4 ernment, or by any person or organization whose property
5 or other legally recognized interest will be adversely af-
6 fected. The proper venue for the civil suit shall be the Fed-
7 eral judicial district with jurisdiction over any portion of
8 the Great Lakes Basin and from which the diversion or
9 export of water will occur or has occurred. The court may
10 award attorney fees, expert witness fees, and costs as the
11 interests of justice may require.”.
