## AN ACT

To amend section 114 of title 17, United States Code, to provide for agreements for the reproduction and performance of sound recordings by webcasters.

## 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Webcaster Settlement
3	Act of 2008".
4	SEC. 2. AGREEMENTS ON BEHALF OF WEBCASTERS.
5	Section 114(f)(5) of title 17, United States Code, is

7	(1) in subparagraph (A)—
8	(A) by striking "small commercial" each
9	place it appears and inserting "commercial";
10	(B) by striking "during the period begin-
11	ning on October 28, 1998, and ending on De-
12	cember 31, 2004" and inserting "for a period
13	of not more than 11 years beginning on Janu-
14	ary 1, 2005";
15	(C) by striking "a copyright arbitration
16	royalty panel or decision by the Librarian of
17	Congress" and inserting "the Copyright Roy-
18	alty Judges"; and
19	(D) in the second sentence, by striking
20	"webcasters shall include" and inserting
21	"webcasters may include";
22	(2) in subparagraph (B), by striking "small
23	commercial" and inserting "commercial";
24	(3) in subparagraph (C)—
25	(A) by striking "Librarian of Congress"
26	and inserting "Copyright Royalty Judges";

1	(B) by striking "small webcasters" and in-
2	serting "webcasters"; and
3	(C) by adding at the end the following:
4	"This subparagraph shall not apply to the ex-
5	tent that the receiving agent and a webcaster
6	that is party to an agreement entered into pur-
7	suant to subparagraph (A) expressly authorize
8	the submission of the agreement in a pro-
9	ceeding under this subsection.";
10	(4) in subparagraph (D)—
11	(A) by striking "the Small Webcasters Set-
12	tlement Act of 2002" and inserting "the
13	Webcaster Settlement Act of 2008"; and
14	(B) by striking "Librarian of Congress of
15	July 8, 2002" and inserting "Copyright Royalty
16	Judges of May 1, 2007"; and
17	(5) in subparagraph (F), by striking "Decem-
18	ber 15, 2002" and all that follows through "2003"
19	and inserting "February 15, 2009".
