### **AN ACT**

- To amend the National Organ Transplant Act to provide that criminal penalties do not apply to paired donations of human kidneys, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Charlie W. Norwood3 Living Organ Donation Act".

## 4 SEC. 2. NATIONAL ORGAN TRANSPLANT ACT; AMENDMENT 5 REGARDING PAIRED DONATION OF HUMAN 6 KIDNEYS.

7 (a) IN GENERAL.—Section 301(a) of the National
8 Organ Transplant Act (42 U.S.C. 274e(a)) is amended by
9 adding at the end the following: "The preceding sentence
10 does not apply with respect to the paired donation of
11 human kidneys.".

(b) DEFINITION.—Section 301(c) of the National
Organ Transplant Act (42 U.S.C. 274e(c)) is amended by
adding at the end the following:

15 "(4) The term 'paired donation of human kid16 neys' means the donation and receipt of human kid17 neys under the following circumstances:

"(A) An individual (referred to in this
paragraph as the 'first donor') desires to make
a living donation of a kidney specifically to a
particular patient (referred to in this paragraph
as the 'first patient'), but such donor is biologically incompatible as a donor for such patient.

25 "(B) A second individual (referred to in26 this paragraph as the 'second donor') desires to

1	make a living donation of a kidney specifically
2	to a second particular patient (referred to in
3	this paragraph as the 'second patient'), but
4	such donor is biologically incompatible as a
5	donor for such patient.
6	"(C) Subject to subparagraph (D), the
7	first donor is biologically compatible as a donor
8	of a kidney for the second patient, and the sec-
9	ond donor is biologically compatible as a donor
10	of a kidney for the first patient.
11	"(D) If there is any additional donor-pa-
12	tient pair as described in subparagraph (A) or
13	(B), each donor in the group of donor-patient
14	pairs is biologically compatible as a donor of a
15	kidney for a patient in such group.
16	"(E) All donors and patients in the group
17	of donor-patient pairs (whether two pairs or
18	more than two pairs) enter into a single agree-
19	ment to donate and receive such kidneys, re-
20	spectively, according to such biological compat-
21	ibility in the group.
22	"(F) Other than as described in subpara-
23	graph (E), no valuable consideration is know-
24	ingly acquired, received, or otherwise trans-

1	ferred with respect to the kidneys referred to in
2	such subparagraph.".
3	SEC. 3. ADDITIONAL FUNDING FOR THE MEDICARE PHYSI-
4	CIAN ASSISTANCE AND QUALITY INITIATIVE
5	FUND.
6	Section $1848(l)(2)$ of the Social Security Act (42)
7	U.S.C. 1395w-4(l)(2)) is amended—
8	(1) in subparagraph (A), by adding at the end
9	the following: "In addition, there shall be available
10	to the Fund for expenditures during 2009 an
11	amount equal to $$30,000,000$ and for expenditures
12	during or after 2013 an amount equal to
13	\$470,000,000."; and
14	(2) in subparagraph (B)—
15	(A) in the heading, by striking "FUR-
16	NISHED DURING 2008";
17	(B) by striking "specified in subparagraph
18	(A)" and inserting "specified in the first sen-
19	tence of subparagraph (A)"; and
20	(C) by inserting after "furnished during
21	2008" the following: "and for the obligation of
22	the entire first amount specified in the second
23	sentence of such subparagraph for payment
24	with respect to physicians' services furnished
25	during 2009 and of the entire second amount

so specified for payment with respect to physi cians' services furnished on or after January 1,
 2013".
