A BILL

To amend title 18, United States Code, to improve the criminal law relating to terrorism, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Criminal Terrorism
- 5 Improvements Act of 2007".

1 SEC. 2. TERRORIST OFFENSE RESULTING IN DEATH.

- 2 (a) New Offense.—Chapter 113B of title 18,
- 3 United States Code, is amended by adding at the end the
- 4 following:

5 "§ 2339E. Terrorist offenses resulting in death

- 6 "(a) Whoever, in the course of committing a terrorist
- 7 offense, engages in conduct that results in the death of
- 8 a person, shall be punished by death or imprisoned for
- 9 any term of years or for life.
- 10 "(b) As used in this section, the term 'terrorist of-
- 11 fense' means—
- "(1) a felony offense that is—
- "(A) a Federal crime of terrorism as de-
- fined in section 2332b(g), other than an offense
- under section 1363; or
- 16 "(B) an offense under this chapter, section
- 17 175b, 229, or 831, or section 236 of the
- 18 Atomic Energy Act of 1954; or
- 19 "(2) a Federal offense that is an attempt or
- 20 conspiracy to commit an offense described in para-
- 21 graph (1).".
- 22 (b) Clerical Amendment.—The table of sections

- 7 (a) IN GENERAL.—Chapter 113B of title 18, United
- 8 States Code, is amended by adding at the end the fol-
- 9 lowing:
- 10 "§ 2339F. Denial of Federal benefits to terrorists
- 11 "(a) IN GENERAL.—Any individual who is convicted
- 12 of a Federal crime of terrorism (as defined in section
- 13 2332b(g)) shall, as provided by the court on motion of
- 14 the Government, be ineligible for any or all Federal bene-
- 15 fits for any term of years or for life.
- 16 "(b) Federal Benefit Defined.—As used in this
- 17 section, 'Federal benefit' has the meaning given that term
- 18 in section 421(d) of the Controlled Substances Act (21
- 19 U.S.C. 862(d)).".
- 20 (b) Table of Sections Amendment.—The table of
- 21 sections of chapter 113B of title 18, United States Code,
- 22 is amended by inserting at the end the following:
