## RESOLUTION

Providing for consideration of the bill (H.R. 2638) making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2008, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 2638) making appropriations for
- 6 the Department of Homeland Security for the fiscal year

- 1 ending September 30, 2008, and for other purposes. The
- 2 first reading of the bill shall be dispensed with. All points
- 3 of order against consideration of the bill are waived except
- 4 those arising under clause 9 or 10 of rule XXI. General
- 5 debate shall be confined to the bill and shall not exceed
- 6 one hour equally divided and controlled by the chairman
- 7 and ranking minority member of the Committee on Appro-
- 8 priations. After general debate the bill shall be considered
- 9 for amendment under the five-minute rule. Points of order
- 10 against provisions in the bill for failure to comply with
- 11 clause 2 of rule XXI are waived. During consideration of
- 12 the bill for amendment, the Chairman of the Committee
- 13 of the Whole may accord priority in recognition on the
- 14 basis of whether the Member offering an amendment has
- 15 caused it to be printed in the portion of the Congressional
- 16 Record designated for that purpose in clause 8 of rule
- 17 XVIII. Amendments so printed shall be considered as
- 18 read. When the committee rises and reports the bill back
- 19 to the House with a recommendation that the bill do pass,
- 20 the previous question shall be considered as ordered on
- 21 the bill and amendments thereto to final passage without
- 22 intervening motion except one motion to recommit with
- 23 or without instructions.
- Sec. 2. During consideration of H.R. 2638 in the
- 25 House pursuant to this resolution, notwithstanding the op-

- 1 eration of the previous question, the Chair may postpone
- 2 further consideration of the bill to such time as may be
- 3 designated by the Speaker.
