Ms. CASTOR, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 986) to amend the Wild and Scenic Rivers Act to designate certain segments of the Eightmile River in the State of Connecticut as components of the National Wild and Scenic Rivers System, and for other purposes.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the bill (H.R.
3 986) to amend the Wild and Scenic Rivers Act to des-
4 ignate certain segments of the Eightmile River in the
5 State of Connecticut as components of the National Wild

1 and Scenic Rivers System, and for other purposes. All
2 points of order against consideration of the bill are waived
3 except those arising under clause 9 or 10 of rule XXI.
4 The amendment in the nature of a substitute rec-
5 ommended by the Committee on Natural Resources now
6 printed in the bill, modified by the amendment printed in
7 the report of the Committee on Rules accompanying this
8 resolution, shall be considered as adopted. The bill, as
9 amended, shall be considered as read. All points of order
10 against provisions of the bill, as amended, are waived. The
11 previous question shall be considered as ordered on the
12 bill, as amended, to final passage without intervening mo-
13 tion except: (1) one hour of debate equally divided and
14 controlled by the chairman and ranking minority member
15 of the Committee on Natural Resources; and (2) one mo-
16 tion to recommit with or without instructions.

17 SEC. 2. During consideration of H.R. 986 pursuant
18 to this resolution, notwithstanding the operation of the
19 previous question, the Chair may postpone further consid-
20 eration of the bill to such time as may be designated by
21 the Speaker.
