Ms. MATSUI, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3121) to restore the financial solvency of the national flood insurance program and to provide for such program to make available multiperil coverage for damage resulting from windstorms and floods, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3121) to restore the financial sol-

1 vency of the national flood insurance program and to pro-  
2 vide for such program to make available multiperil cov-  
3 erage for damage resulting from windstorms and floods,  
4 and for other purposes. The first reading of the bill shall  
5 be dispensed with. All points of order against consider-  
6 ation of the bill are waived except those arising under  
7 clause 9 or 10 of rule XXI. General debate shall be con-  
8 fined to the bill and shall not exceed one hour equally di-  
9 vided and controlled by the chairman and ranking minor-  
10 ity member of the Committee on Financial Services. After  
11 general debate the bill shall be considered for amendment  
12 under the five-minute rule. The amendment in the nature  
13 of a substitute recommended by the Committee on Finan-  
14 cial Services now printed in the bill, modified by the  
15 amendment printed in part A of the report of the Com-  
16 mittee on Rules accompanying this resolution, shall be  
17 considered as adopted in the House and in the Committee  
18 of the Whole. The bill, as amended, shall be considered  
19 as the original bill for the purpose of further amendment  
20 under the five-minute rule and shall be considered as read.  
21 All points of order against provisions in the bill, as amend-  
22 ed, are waived. Notwithstanding clause 11 of rule XVIII,  
23 no further amendment to the bill, as amended, shall be  
24 in order except those printed in part B of the report of  
25 the Committee on Rules. Each further amendment may

1 be offered only in the order printed in the report, may  
2 be offered only by a Member designated in the report,  
3 shall be considered as read, shall be debatable for the time  
4 specified in the report equally divided and controlled by  
5 the proponent and an opponent, shall not be subject to  
6 amendment, and shall not be subject to a demand for divi-  
7 sion of the question in the House or in the Committee  
8 of the Whole. All points of order against such further  
9 amendments are waived except those arising under clause  
10 9 or 10 of rule XXI. At the conclusion of consideration  
11 of the bill for amendment the Committee shall rise and  
12 report the bill, as amended, to the House with such fur-  
13 ther amendments as may have been adopted. The previous  
14 question shall be considered as ordered on the bill and  
15 amendments thereto to final passage without intervening  
16 motion except one motion to recommit with or without in-  
17 structions.

18 SEC. 2. During consideration in the House of H.R.  
19 3121 pursuant to this resolution, notwithstanding the op-  
20 eration of the previous question, the Chair may postpone  
21 further consideration of the bill to such time as may be  
22 designated by the Speaker.
