A BILL

To grant a Federal charter to Korean War Veterans Association, Incorporated.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 2 SECTION 1. GRANT OF FEDERAL CHARTER TO KOREAN 4 WAR **VETERANS** ASSOCIATION, **INCOR-**5 PORATED. (a) Grant of Charter.—Part B of subtitle II of 6 title 36, United States Code, is amended— 8 (1) by striking the following:

1 **"CHAPTER 1201—[RESERVED]";**

- 3 (2) by inserting after chapter 1103 the fol-
- 4 lowing new chapter:

7 "§ 120101. Organization

- 8 "(a) Federal Charter.—Korean War Veterans
- 9 Association, Incorporated (in this chapter, the 'corpora-
- 10 tion'), a nonprofit organization that meets the require-
- 11 ments for a veterans service organization under section
- 12 501(c)(19) of the Internal Revenue Code of 1986 and that
- 13 is organized under the laws of the State of New York,
- 14 is a federally chartered corporation.
- 15 "(b) Expiration of Charter.—If the corporation
- 16 does not comply with the provisions of this chapter, the
- 17 charter granted by subsection (a) shall expire.

1 "§ 120102. Purposes

- 2 "The purposes of the corporation are those provided
- 3 in the articles of incorporation of the corporation and shall
- 4 include the following:
- 5 "(1) To organize as a veterans service organiza-
- 6 tion in order to maintain a continuing interest in the
- 7 welfare of veterans of the Korean War, and rehabili-
- 8 tation of the disabled veterans of the Korean War to
- 9 include all that served during active hostilities and
- subsequently in defense of the Republic of Korea,
- and their families.
- 12 "(2) To establish facilities for the assistance of
- all veterans and to represent them in their claims
- before the Department of Veterans Affairs and other
- organizations without charge.
- 16 "(3) To perpetuate and preserve the comrade-
- ship and friendships born on the field of battle and
- nurtured by the common experience of service to the
- 19 United States during the time of war and peace.
- 20 "(4) To honor the memory of the men and
- 21 women who gave their lives so that the United
- 22 States and the world might be free and live by the
- creation of living memorial, monuments, and other
- forms of additional educational, cultural, and rec-
- 25 reational facilities.

- 1 "(5) To preserve for the people of the United
- 2 States and posterity of such people the great and
- 3 basic truths and enduring principles upon which the
- 4 United States was founded.

5 "§ 120103. Membership

- 6 "Eligibility for membership in the corporation, and
- 7 the rights and privileges of members of the corporation,
- 8 are as provided in the bylaws of the corporation.

9 **"§ 120104. Governing body**

- 10 "(a) BOARD OF DIRECTORS.—The composition of the
- 11 board of directors of the corporation, and the responsibil-
- 12 ities of the board, are as provided in the articles of incor-
- 13 poration of the corporation.
- 14 "(b) Officers.—The positions of officers of the cor-
- 15 poration, and the election of the officers, are as provided
- 16 in the articles of incorporation.

17 **"§ 120105. Powers**

- 18 "The corporation has only those powers provided in
- 19 its bylaws and articles of incorporation filed in each State
- 20 in which it is incorporated.

21 **"§ 120106. Restrictions**

- 22 "(a) Stock and Dividends.—The corporation may
- 23 not issue stock or declare or pay a dividend.
- 24 "(b) Political Activities.—The corporation, or a
- 25 director or officer of the corporation as such, may not con-

- 1 tribute to, support, or participate in any political activity
- 2 or in any manner attempt to influence legislation.
- 3 "(c) Loan.—The corporation may not make a loan
- 4 to a director, officer, or employee of the corporation.
- 5 "(d) Claim of Governmental Approval or Au-
- 6 THORITY.—The corporation may not claim congressional
- 7 approval, or the authority of the United States, for any
- 8 activity of the corporation.
- 9 "(e) Corporate Status.—The corporation shall
- 10 maintain its status as a corporation incorporated under
- 11 the laws of the State of New York.
- 12 "§ 120107. Tax-exempt status required as condition of
- 13 **charter**
- "If the corporation fails to maintain its status as an
- 15 organization exempt from taxation under the Internal
- 16 Revenue Code of 1986, the charter granted under this
- 17 chapter shall terminate.
- 18 "§ 120108. Records and inspection
- 19 "(a) Records.—The corporation shall keep—
- 20 "(1) correct and complete records of account;
- 21 "(2) minutes of the proceedings of the mem-
- bers, board of directors, and committees of the cor-
- poration having any of the authority of the board of
- 24 directors of the corporation; and

- 1 "(3) at the principal office of the corporation,
- 2 a record of the names and addresses of the members
- 3 of the corporation entitled to vote on matters relat-
- 4 ing to the corporation.
- 5 "(b) Inspection.—A member entitled to vote on any
- 6 matter relating to the corporation, or an agent or attorney
- 7 of the member, may inspect the records of the corporation
- 8 for any proper purpose, at any reasonable time.

9 "§ 120109. Service of process

- 10 "The corporation shall have a designated agent in the
- 11 District of Columbia to receive service of process for the
- 12 corporation. Notice to or service on the agent is notice
- 13 to or service on the corporation.

14 "§ 120110. Liability for acts of officers and agents

- 15 "The corporation is liable for any act of any officer
- 16 or agent of the corporation acting within the scope of the
- 17 authority of the corporation.

18 **"§ 120111. Annual report**

- 19 "The corporation shall submit to Congress an annual
- 20 report on the activities of the corporation during the pre-
- 21 ceding fiscal year. The report shall be submitted at the
- 22 same time as the report of the audit required by section
- 23 10101(b) of this title. The report may not be printed as
- 24 a public document.

1 **"§ 120112. Definition**

- 2 "For purposes of this chapter, the term 'State' in-
- 3 cludes the District of Columbia and the territories and
- 4 possessions of the United States.".
- 5 (b) CLERICAL AMENDMENT.—The item relating to
- 6 chapter 1201 in the table of chapters at the beginning of
- 7 subtitle II of title 36, United States Code, is amended to
- 8 read as follows:
