A BILL

To amend the Act of February 22, 1889, and the Act of July 2, 1862, to provide for the management of public land trust funds in the State of North Dakota.

1 SECTION 1. SHORT TITLE.

5 SEC. 2. MANAGEMENT AND DISTRIBUTION OF NORTH DA-

- 6 KOTA TRUST FUNDS.
- 7 The Act of February 22, 1889 (25 Stat. 676, chapter
- 8 180), is amended by adding at the end the following:
- 9 "SEC. 26. NORTH DAKOTA TRUST FUNDS.
- 10 "(a) DISPOSITION.—Notwithstanding section 11, the
- 11 State of North Dakota shall, with respect to any trust
- 12 fund in which proceeds from the sale of public land are
- 13 deposited under this Act (referred to in this section as the
- 14 'trust fund')—
- 15 "(1) deposit all revenues earned by a trust fund
- into the trust fund;
- 17 "(2) deduct the costs of administering a trust
- 18 fund from each trust fund; and
- 19 "(3) manage each trust fund to—
- 20 "(A) preserve the purchasing power of the
- 21 trust fund; and
- 22 "(B) maintain stable distributions to trust
- fund beneficiaries.
- "(b) DISTRIBUTIONS.—Notwithstanding section 11,
- 25 any distributions from trust funds in the State of North

- 3 "(c) Management of Proceeds.—Notwith-

- 7 "(d) Management of Land and Proceeds.—Not-
- 8 withstanding sections 14 and 16, the State of North Da-

- 10 including any proceeds from the land, and make distribu-
- 11 tions in accordance with subsections (a) and (b).".
- 12 SEC. 3. MANAGEMENT AND DISTRIBUTION OF MORRILL
- 13 ACT GRANTS.
- The Act of July 2, 1862 (commonly known as the
- 15 "First Morrill Act") (7 U.S.C. 301 et seq.), is amended
- 16 by adding at the end the following:
- 17 "SEC. 9. LAND GRANTS IN THE STATE OF NORTH DAKOTA.
- 18 "(a) Expenses.—Notwithstanding section 3, the
- 19 State of North Dakota shall manage the land granted to
- 20 the State under the first section, including any proceeds
- 21 from the land, in accordance with this section.
- 22 "(b) Disposition of Proceeds.—Notwithstanding
- 23 section 4, the State of North Dakota shall, with respect
- 24 to any trust fund in which proceeds from the sale of land

- 1 under this Act are deposited (referred to in this section
- 2 as the 'trust fund')—
- 3 "(1) deposit all revenues earned by a trust fund
- 4 into the trust fund;
- 5 "(2) deduct the costs of administering a trust
- 6 fund from each trust fund; and
- 7 "(3) manage each trust fund to—
- 8 "(A) preserve the purchasing power of the
- 9 trust fund; and
- 10 "(B) maintain stable distributions to trust
- fund beneficiaries.
- 12 "(c) DISTRIBUTIONS.—Notwithstanding section 4,
- 13 any distributions from trust funds in the State of North
- 14 Dakota shall be made in accordance with section 2 of arti-
- 15 cle IX of the Constitution of the State of North Dakota.
- 16 "(d) Management.—Notwithstanding section 5, the
- 17 State of North Dakota shall manage the land granted
- 18 under the first section, including any proceeds from the
- 19 land, in accordance with this section.".
- 20 SEC. 4. CONSENT OF CONGRESS.
- 21 Effective July 1, 2009, Congress consents to the
- 22 amendments to the Constitution of North Dakota pro-
- 23 posed by House Concurrent Resolution No. 3037 of the
- 24 59th Legislature of the State of North Dakota entitled
- 25 "A concurrent resolution for the amendment of sections

- 1 1 and 2 of article IX of the Constitution of North Dakota,
- 2 relating to distributions from and the management of the
- 3 common schools trust fund and the trust funds of other
- 4 educational or charitable institutions; and to provide a
- 5 contingent effective date" and approved by the voters of
- 6 the State of North Dakota on November 7, 2006.
