A BILL

To amend the Animal Welfare Act to prohibit dog fighting ventures.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. PROHIBITIONS ON DOG FIGHTING VENTURES.
4	(a) In General.—Section 26 of the Animal Welfare
5	Act (7 U.S.C. 2156) is amended—
6	(1) in subsection (a)(1)—
7	(A) by striking "any person to knowingly
8	sponsor" and inserting "any person—
9	"(A) to knowingly sponsor";

1	(B) by striking the period at the end and
2	inserting "; or"; and
3	(C) by adding at the end the following:
4	"(B) to knowingly sponsor or exhibit an
5	animal in, or knowingly attend, a dog fighting
6	venture.";
7	(2) in subsection (b)—
8	(A) by striking "any person to knowingly
9	sell" and inserting "any person—
10	"(A) to knowingly sell"; and
11	(B) by striking the period at the end and
12	inserting "; or"; and
13	(C) by adding at the end the following:
14	"(B) to knowingly sell, buy, possess, train,
15	transport, deliver, or receive for purposes of
16	transportation, any dog or other animal for the
17	purposes of having the dog or other animal, or
18	offspring of the dog or other animal, participate
19	in a dog fighting venture."; and
20	(3) in subsection (g)—
21	(A) in paragraph (5), by striking "and" at
22	the end;
23	(B) by redesignating paragraph (6) as
24	paragraph (7); and

1	(C) by inserting after paragraph (5) the
2	following:
3	"(6) the term 'dog fighting venture'—
4	"(A) means any event that—
5	"(i) involves a fight between at least
6	2 animals;
7	"(ii) includes at least 1 dog; and
8	"(iii) is conducted for purposes of
9	sport, wagering, or entertainment; and
10	"(B) does not include any activity the pri-
11	mary purpose of which involves the use of 1 or
12	more animals to hunt another animal; and".
13	(b) Enforcement of Animal Fighting Prohibi-
14	TIONS.—Section 49 of title 18, United States Code, is
15	amended by inserting "(or in the case of a dog fighting
16	venture (as defined in section 26(g) of that Act) not more
17	than 5 years)" before ", or both".
