A BILL

To direct the Secretary of the Interior to study the suitability and feasibility of designating the Wolf House, located in Norfolk, Arkansas, as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Wolf House Study Act
3 of 2007”.

4 **SEC. 2. FINDING.**

5 Congress finds that the Wolf House, located in Nor-
6 folk, Arkansas, is the oldest 2-story log structure and the
7 oldest territorial courthouse west of the Mississippi River.

8 **SEC. 3. DEFINITIONS.**

9 In this Act:

10 (1) **SECRETARY.**—The term “Secretary” means
11 the Secretary of the Interior, acting through the Di-
12 rector of the National Park Service.

13 (2) **WOLF HOUSE.**—The term “Wolf House”
14 means the structure known by that name located on
15 Highway 5 in Norfolk, Arkansas.

16 **SEC. 4. WOLF HOUSE STUDY.**

17 (a) **IN GENERAL.**—The Secretary, in consultation
18 with the State of Arkansas, shall—

19 (1) carry out a study on the suitability and fea-
20 sibility of designating the Wolf House as a unit of
21 the National Park System; and

22 (2) consider management alternatives for the
23 Wolf House.

24 (b) **APPLICABLE LAW.**—Except as provided by sub-
25 section (e), section 8(e) of Public Law 91–383 (16 U.S.C.

1 ~~1a-5(e))~~ shall apply to the conduct and completion of the
 2 study required by subsection (a).

3 (c) **REPORT.**—Not later than 1 year after the date
 4 of enactment of this Act, the Secretary shall submit to
 5 the Committee on Natural Resources of the House of Rep-
 6 resentatives and the Committee on Energy and Natural
 7 Resources of the Senate a report describing the results
 8 of the study.

9 **SECTION 1. SHORT TITLE.**

10 *This Act may be cited as the “Wolf House Study Act*
 11 *of 2008”.*

12 **SEC. 2. DEFINITIONS.**

13 *In this Act:*

14 (1) **SECRETARY.**—*The term “Secretary” means*
 15 *the Secretary of the Interior.*

16 (2) **WOLF HOUSE.**—*The term “Wolf House”*
 17 *means the structure known by that name located on*
 18 *Highway 5 in Norfolk, Arkansas.*

19 **SEC. 3. WOLF HOUSE STUDY.**

20 (a) **IN GENERAL.**—*In accordance with subsection (b),*
 21 *the Secretary shall complete a special resource study of the*
 22 *Wolf House to determine—*

23 (1) *the suitability and feasibility of designating*
 24 *the Wolf House as a unit of the National Park Sys-*
 25 *tem; and*

1 (2) *the methods and means for the protection*
 2 *and interpretation of the Wolf House by—*

3 (A) *the National Park Service;*

4 (B) *other entities of the Federal Govern-*
 5 *ment;*

6 (C) *State and local government entities;*

7 *and*

8 (D) *private and nonprofit organizations.*

9 (b) *STUDY REQUIREMENTS.—The Secretary shall con-*
 10 *duct the study in accordance with section 8(c) of Public*
 11 *Law 91–383 (16 U.S.C. 1a–5(c)).*

12 (c) *REPORT.—Not later than 3 years after the date on*
 13 *which funds are made available to carry out this section,*
 14 *the Secretary shall submit to the Committee on Energy and*
 15 *Natural Resources of the Senate and the Committee on Nat-*
 16 *ural Resources of the House of Representatives a report con-*
 17 *taining—*

18 (1) *the results of the study; and*

19 (2) *any recommendations of the Secretary.*

Amend the title so as to read: “A bill to authorize the Secretary of the Interior to study the suitability and feasibility of designating the Wolf House, located in Norfolk, Arkansas, as a unit of the National Park System, and for other purposes.”.
