## A BILL

To make certain technical corrections to title III of  
SAFETEA-LU.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TECHNICAL CORRECTIONS TO SAFETEA-LU.**

4       (a) ALTERNATIVES ANALYSIS.—Section 3037(c)(15)  
5 of the Safe, Accountable, Flexible, Efficient Transpor-  
6 tation Equity Act: A Legacy for Users (Public Law 109–  
7 59) is amended by striking “South Carolina Department  
8 of Transportation Light Rail study” and inserting “South  
9 Carolina Department of Transportation Corridor Study”.

1 (b) BUS AND BUS FACILITIES.—Section 3044(a) of  
2 the Safe, Accountable, Flexible, Efficient Transportation  
3 Equity Act: A Legacy for Users is amended by—

4 (1) amending the project description for item 6  
5 to read as follows: “Los Angeles, CA Construction of  
6 a Hydrogen Fueling Station at California State Uni-  
7 versity Los Angeles”;

8 (2) amending the project description for item  
9 67 to read as follows: “Union Passenger Terminal  
10 Planning and Master Plan and Infrastructure Im-  
11 provements in Orleans Parish, Louisiana”;

12 (3) amending the project description for item  
13 232 to read as follows: “WMATA environmental as-  
14 sessment, preliminary engineering, design, and con-  
15 struction related to the transfer of WMATA buses  
16 from the Alexandria, Virginia Royal Street Bus Ga-  
17 rage to an alternate WMATA facility”;

18 (4) amending the project description for item  
19 422 to read as follows: “People Mover Public Trans-  
20 portation System buses and bus facilities, Anchor-  
21 age, Alaska”;

22 (5) amending the project description for item  
23 494 to read as follows: “WMATA environmental as-  
24 sessment, preliminary engineering, design, and con-  
25 struction related to the transfer of WMATA buses

1 from the Alexandria, Virginia Royal Street Bus Ga-  
2 rage to an alternate WMATA facility”; and

3 (6) amending the project description for item  
4 598 to read as follows: “OATS, Inc. – Bus and Bus  
5 Facilities”.

6 (c) AVAILABILITY OF AMOUNTS.—Section 3044 of  
7 the Safe, Accountable, Flexible, Efficient Transportation  
8 Equity Act: A Legacy for Users is amended by adding at  
9 the end the following:

10 “(d) AVAILABILITY OF AMOUNTS.—Amounts made  
11 available to a project in fiscal year 2006 pursuant to sub-  
12 section (a) shall be available to that project for obligation  
13 until September 30, 2009.”.
