### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Respecting States5 Rights and Concealed Carry Reciprocity Act of 2008".

# 1SEC. 2. RECIPROCITY FOR THE CARRYING OF CERTAIN2CONCEALED FIREARMS.

3 (a) IN GENERAL.—Chapter 44 of title 18, United
4 States Code, is amended by inserting after section 926C
5 the following:

6 "§926D. Reciprocity for the carrying of certain con7 cealed firearms

8 "Notwithstanding any provision of the law of any9 State or political subdivision thereof:

10 "(1) A person who is not prohibited by Federal 11 law from possessing, transporting, shipping, or re-12 ceiving a firearm, and is carrying a valid license or 13 permit which is issued pursuant to the law of any 14 State and which permits the person to carry a con-15 cealed firearm, may carry in any State a concealed 16 firearm in accordance with the terms of the license 17 or permit, subject to the laws of the State in which 18 the firearm is carried concerning specific types of lo-19 cations in which firearms may not be carried.

"(2) A person who is not prohibited by Federal
law from possessing, transporting, shipping, or receiving a firearm, and is otherwise than as described
in paragraph (1) entitled to carry a concealed firearm in and pursuant to the law of the State in
which the person resides, may carry in any State a
concealed firearm in accordance with the laws of the

State in which the person resides, subject to the
 laws of the State in which the firearm is carried con cerning specific types of locations in which firearms
 may not be carried.".

5 (b) CLERICAL AMENDMENT.—The table of sections
6 for chapter 44 of title 18 is amended by inserting after
7 the item relating to section 926C the following:
"926D. Reciprocity for the carrying of certain concealed firearms.".

### 8 SEC. 3. EFFECTIVE DATE.

9 The amendments made by this Act shall take effect10 90 days after the date of enactment of this Act.
