A BILL

To direct the Secretary of the Interior to conduct a study of water resources in the State of New Mexico.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "New Mexico Aquifer
- 5 Assessment Act of 2007".

1 SEC. 2. NEW MEXICO WATER RESOURCES STUDY.

2	(a) In General.—The Secretary of the Interior, act-
3	ing through the Director of the United States Geological
4	Survey (referred to in this Act as the "Secretary"), in co-
5	ordination with the State of New Mexico (referred to in
6	this Act as the "State") and any other entities that the
7	Secretary determines to be appropriate (including other
8	Federal agencies and institutions of higher education),
9	shall, in accordance with this Act and any other applicable
10	law, conduct a study of water resources in the State, in-
11	cluding—
12	(1) a survey of groundwater resources, includ-
13	ing an analysis of—
14	(A) aquifers in the State, including the
15	quantity of water in the aquifers;
16	(B) the availability of groundwater re-
17	sources for human use;
18	(C) the salinity of groundwater resources;
19	(D) the potential of the groundwater re-
20	sources to recharge;
21	(E) the interaction between groundwater
22	and surface water;
23	(F) the susceptibility of the aquifers to
24	contamination; and
25	(G) any other relevant criteria; and

- 1 (2) a characterization of surface and bedrock
- 2 geology, including the effect of the geology on
- 3 groundwater yield and quality.
- 4 (b) Study Areas.—The study carried out under
- 5 subsection (a) shall include the Estancia Basin, Salt
- 6 Basin, Tularosa Basin, Hueco Basin, and middle Rio
- 7 Grande Basin in the State.
- 8 (c) Report.—Not later than 2 years after the date
- 9 of enactment of this Act, the Secretary shall submit to
- 10 the Committee on Energy and Natural Resources of the
- 11 Senate and the Committee on Resources of the House of
- 12 Representatives a report that describes the results of the
- 13 study.
- 14 (d) AUTHORIZATION OF APPROPRIATIONS.—There
- 15 are authorized to be appropriated such sums as are nec-
- 16 essary to carry out this Act.
