# A BILL

To deauthorize a certain portion of the project for navigation, Rockland Harbor, Maine.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ROCKLAND HARBOR, MAINE.
- 4 As of the date of enactment of this Act, the portion
- 5 of the project for navigation, Rockland Harbor, Maine, au-
- 6 thorized by the Act of June 3, 1896 (29 Stat. 202, chapter
- 7 314), consisting of a 14-foot channel located in Lermond
- 8 Cove and beginning at a point with coordinates N.
- 9 99977.37, E. 340290.02, thence running easterly about
- 10 200.00 feet to a point with coordinates N. 99978.49, E.

- 1 340490.02, thence running northerly about 138.00 feet to
- 2 a point with coordinates N. 100116.49, E. 340289.25,
- 3 thence running westerly about 200.00 feet to a point with
- 4 coordinates N. 100115.37, E. 340289.25, thence running
- 5 southerly about 138.00 feet to the point of origin, is not
- 6 authorized.

### 7 SEC. 2. REDESIGNATION OF PROJECT FOR NAVIGATION,

- 8 SACO RIVER, MAINE.
- 9 The portion of the project for navigation, Saco River,
- 10 Maine, authorized under section 107 of the River and
- 11 Harbor Act of 1960 (33 U.S.C. 577) and described as a
- 12 6-foot deep, 10-acre maneuvering basin located at the
- 13 head of navigation, is redesignated as an anchorage area.
- 14 SEC. 3. HERBERT HOOVER DIKE SUPPLEMENTAL MAJOR
- 15 REHABILITATION REPORT.
- 16 (a) IN GENERAL.—Not later than May 31, 2007, the
- 17 Secretary shall publish a supplement to the major rehabili-
- 18 tation report for the Herbert Hoover Dike system, ap-
- 19 proved by the Chief of Engineers in November 2000.
- 20 (b) Inclusions.—The supplemental report under
- 21 subsection (a) shall include—
- 22 (1) an evaluation of existing conditions at the
- 23 Herbert Hoover Dike system;

1	(2) an identification of additional risks associ-
2	ated with flood events at the system that are equal
3	to or greater than the standard projected flood risks;
4	(3) an evaluation of the potential to integrate
5	projects of the Corps of Engineers into an enhanced
6	flood protection system for Lake Okeechobee, includ-
7	ing—
8	(A) the potential for additional water stor-
9	age north of Lake Okeechobee; and
10	(B) an analysis of other project features
11	included in the Comprehensive Everglades Res-
12	toration Plan; and
13	(4) a review of the report prepared for the
14	South Florida Water Management District dated
15	April 2006.
16	(c) AUTHORIZATION OF APPROPRIATIONS.—There is
17	authorized to be appropriated to carry out this section
18	\$1,500,000.
19	SEC. 4. ILLINOIS WATERWAY, SOUTH FORK OF THE SOUTH
20	BRANCH OF THE CHICAGO RIVER, ILLINOIS.
21	(a) In General.—The portion of the Illinois Water-
22	way project authorized by the Act of January 21, 1927
23	(commonly known as the "River and Harbor Act of
24	1927") (44 Stat. 1013), in the South Fork of the South

- 1 Branch of the Chicago River, as identified in subsection
- 2 (b) is not authorized.
- 3 (b) Description of Project Portion.—The por-
- 4 tion of the project referred to in subsection (a) is the por-
- 5 tion of the SW ¼ of sec. 29, T. 39 N., R. 14 E., Third
- 6 Principal Meridian, Cook County, Illinois, and more par-
- 7 ticularly described as follows:
- 8 (1) Commencing at the SW corner of the SW
- 9 1/4.
- 10 (2) Thence north 1 degree, 32 minutes, 31 sec-
- onds west, bearing based on the Illinois State Plane
- 12 Coordinate System, NAD 83 east zone, along the
- west line of that quarter, 1810.16 feet to the south-
- erly line of the Illinois and Michigan Canal.
- 15 (3) Thence north 50 degrees, 41 minutes, 55
- seconds east along that southerly line 62.91 feet to
- the easterly line of South Ashland Avenue, as wid-
- ened by the ordinance dated November 24, 1920,
- which is also the east line of an easement to the
- 20 State of Illinois for highway purposes numbered
- 21 12340342 and recorded July 13, 1939, for a point
- of beginnings.
