A BILL

To amend the Morris K. Udall Scholarship and Excellence in National Environmental and Native American Public Policy Act of 1992 to provide funds for training in tribal leadership, management, and policy, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. FINDINGS.
- 4 Congress finds that—
- 5 (1) the Federal Government favors a policy of
- 6 self-determination for Indian tribes;

1	(2) consistent with the policy described in para-
2	graph (1), Indian tribes continue to assume more
3	control of the affairs of the Indian tribes in order
4	to exercise the status provided to the Indian tribes
5	in treaties, court decisions, and legislation;
6	(3) as a result of that increased assumption of
7	control, Indian tribes require enhanced leadership
8	preparation and greater access to information—
9	(A) relating to the research and analysis of
10	successful models for tribal government and
11	business operations; and
12	(B) that is similar to the information regu-
13	larly available to Federal, State, and local gov-
14	ernments;
15	(4) enabling Indian tribes to develop a strong
16	leadership and governing policy—
17	(A) is consistent with the policy of the
18	Federal Government relating to the encourage-
19	ment and support of tribal self-determination;
20	and
21	(B) increases the likelihood that tribal gov-
22	ernments will achieve political and economic
23	self-determination; and
24	(5) in accordance with section 6(7) of the Mor-
25	ris K. Udall Scholarship and Excellence in National

8	of the quality and type required by Indian tribes for

10	SEC. 2. NATIVE NATIONS LEADERSHIP, MANAGEMENT, AND
11	POLICY.
12	(a) Definitions.—Section 4 of the Morris K. Udall
13	Scholarship and Excellence in National Environmental
14	and Native American Public Policy Act of 1992 (20
15	U.S.C. 5602) is amended—
16	(1) in the matter preceding paragraph (1), by
17	striking "For the purposes of this Act—" and in-
18	serting "In this Act—";
19	(2) by redesignating paragraphs (6) through
20	(9) as paragraphs (7) through (10), respectively;
21	and
22	(3) by inserting after paragraph (5) the fol-
23	lowing:
24	"(6) the terms 'Indian tribe' and 'tribe' have
25	the meaning given the term 'Indian tribe' in section

1	4 of the Indian Self-Determination and Education
2	Assistance Act (25 U.S.C. 450b).".
3	SEC. 3. AUTHORIZATION OF APPROPRIATIONS.
4	Section 13 of the Morris K. Udall Scholarship and
5	Excellence in National Environmental and Native Amer-
6	ican Public Policy Act of 1992 (20 U.S.C. 5609) is amend-
7	ed by striking subsection (c) and adding the following:
8	"(c) Training in Tribal Leadership, Manage-
9	MENT, AND POLICY.—
10	"(1) In general.—There are authorized to be
11	appropriated to carry out section (6)(7)—
12	"(A) \$500,000 for each of fiscal years
13	2008 and 2009;
14	"(B) $$750,000$ for fiscal year 2010; and
15	"(C) \$1,000,000 for each of fiscal years
16	2011 and 2012.
17	"(2) Exception.—An appropriation made
18	under paragraph (1) shall not be subject to section
19	7(e).".
