CONCURRENT RESOLUTION

Providing for the acceptance of a statue of Ronald Wilson Reagan from the people of California for placement in the United States Capitol.

1 **SECTION 1. ACCEPTANCE OF STATUE OF RONALD WILSON**
 2 **REAGAN FROM THE PEOPLE OF CALIFORNIA**
 3 **FOR PLACEMENT IN UNITED STATES CAP-**
 4 **ITOL.**

5 (a) IN GENERAL.—The statue of Ronald Wilson
 6 Reagan furnished by the people of California for place-
 7 ment in the United States Capitol in accordance with sec-
 8 tion 1814 of the Revised Statutes of the United States
 9 (2 U.S.C. 2131), is accepted in the name of the United
 10 States, and the thanks of the Congress are tendered to
 11 the people of California for providing this commemoration
 12 of one of California’s most eminent persons.

13 (b) PRESENTATION CEREMONY.—The State of Cali-
 14 fornia is authorized to use the rotunda of the Capitol on
 15 June 3, 2009, for a presentation ceremony for the statue
 16 accepted under this section. The Architect of the Capitol
 17 and the Capitol Police Board shall take such action as
 18 may be necessary with respect to physical preparations
 19 and security for the ceremony.

20 (c) DISPLAY IN ROTUNDA.—The Architect of the
 21 Capitol shall provide for the display of the statue accepted
 22 under this section in the rotunda of the Capitol, in accord-
 23 ance with the procedures described in section 311(e) of
 24 the Legislative Branch Appropriations Act, 2001 (2
 25 U.S.C. 2132(e)).
