- 10 Congress from Tuesday, January 5, 2010, through Satur-
- 11 day, January 9, 2010, on a motion offered pursuant to
- 12 this concurrent resolution by its Majority Leader or his
- 13 designee, it shall stand adjourned until noon on Tuesday,
- 14 January 12, 2010, or until the time of any reassembly
- 15 pursuant to section 3 of this concurrent resolution, which-
- 16 ever occurs first; and that when the Senate recesses or
- 17 adjourns on any day of the second session of the One Hun-
- 18 dred Eleventh Congress from Tuesday, January 5, 2010,
- 19 through Saturday, January 9, 2010, on a motion offered
- 20 pursuant to this concurrent resolution by its Majority
- 21 Leader or his designee, it shall stand recessed or ad-
- 22 journed until noon on Tuesday, January 19, 2010, or until
- 23 such other time on that day as may be specified by its
- 24 Majority Leader or his designee in the motion to recess
- 25 or adjourn, or until the time of any reassembly pursuant
