5	"Not later than 180 days after the date of the enact-
6	ment of this section, the Director of the Office of Manage-
7	ment and Budget shall issue guidance that each agency
8	Chief Financial Officer shall follow in compiling the multi-
9	lingual services accounting information required under
10	section $902(a)(6)(E)$ of this title.".
