A BILL

To reauthorize through 2014 certain programs under the Adam Walsh Child Protection and Safety Act of 2006.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Adam Walsh Child
5 Protection and Safety Reauthorization Act of 2009”.

1 **SEC. 2. REAUTHORIZATION OF CHILD PROTECTION PRO-**
2 **GRAMS UNDER THE ADAM WALSH CHILD**
3 **PROTECTION AND SAFETY ACT OF 2006.**

4 The Adam Walsh Child Protection and Safety Act of
5 2006 (42 U.S.C. 16901 et seq.) is amended as follows:

6 (1) SEX OFFENDER MANAGEMENT ASSISTANCE
7 (SOMA) PROGRAM.—Section 126(d) of such Act (42
8 U.S.C. 16926(d)) is amended by striking “2007
9 through 2009” and inserting “2010 through 2014”.

10 (2) FEDERAL ASSISTANCE WITH RESPECT TO
11 VIOLATIONS OF REGISTRATION REQUIREMENTS.—
12 Section 142(b) of such Act (42 U.S.C. 16941(b)) is
13 amended by striking “2007 through 2009” and in-
14 serting “2010 through 2014”.

15 (3) PILOT PROGRAM FOR MONITORING SEXUAL
16 OFFENDERS.—Section 621(c) (42 U.S.C. 16981) of
17 such Act is amended—

18 (A) in paragraph (1), by striking “2007
19 through 2009” and inserting “2010 through
20 2014”; and

21 (B) in paragraph (2), by inserting “and
22 after September 1, 2014, but not later than
23 September 1, 2015” after “September 1,
24 2010,”.

25 (4) GRANTS TO COMBAT SEXUAL ABUSE OF
26 CHILDREN.—Section 625(d) of such Act (42 U.S.C.

1 16983(d)) is amended by striking “2007 through
2 2009” and inserting “2010 through 2014”.

3 (5) JESSICA LUNSFORD ADDRESS VERIFICATION
4 GRANT PROGRAM.—Section 631(e) of such Act (42
5 U.S.C. 16988(e)) is amended—

6 (A) in paragraph (1), by striking “2007
7 through 2009” and inserting “2010 through
8 2014”; and

9 (B) in paragraph (2), by inserting “and
10 after April 1, 2014, but not later than April 1,
11 2015,” after “April 1, 2009,”.

12 (6) FUGITIVE SAFE SURRENDER.—Section
13 632(c) of such Act (42 U.S.C. 16989(c)) is amended
14 by striking “this section—” and all that follows
15 through the period and inserting “this section
16 \$8,000,000 for each of the fiscal years 2009 through
17 2014.”.

18 **SEC. 3. REAUTHORIZATION OF SEX OFFENDER APPREHEN-**
19 **SION GRANTS AND JUVENILE SEX OFFENDER**
20 **TREATMENT GRANTS.**

21 Part KK of title I of the Omnibus Crime Control and
22 Safe Streets Act of 1968 (as added by section 623 of the
23 Adam Walsh Child Protection and Safety Act of 2006 and
24 redesignated by section 114(1) of Public Law 110–199
25 (122 Stat. 677)), relating to sex offender apprehension

1 grants; juvenile sex offender treatment grants, is amend-
2 ed—

3 (1) in section 3011(b) (42 U.S.C. 3797ee(b)),
4 by striking “2007 through 2009” and inserting
5 “2010 through 2014”; and

6 (2) in section 3012(c) (42 U.S.C. 3797ee–1(c)),
7 by striking “2007 through 2009” and inserting
8 “2010 through 2014”.
