## A BILL

To provide for the issuance of a Multinational Species  
Conservation Funds Semipostal Stamp.

- 1 *Be it enacted by the Senate and House of Representa-*
- 2 *tives of the United States of America in Congress assembled,*
- 3 **SECTION 1. SHORT TITLE.**
- 4 *This Act may be cited as the “Multinational Species*
- 5 *Conservation Funds Semipostal Stamp Act of 2009”.*

1 **SEC. 2. MULTINATIONAL SPECIES CONSERVATION FUNDS**  
2 **SEMIPOSTAL STAMP.**

3 (a) *IN GENERAL.*—*In order to afford a convenient way*  
4 *for members of the public to contribute to funding for the*  
5 *operations supported by the Multinational Species Con-*  
6 *servation Funds, the United States Postal Service shall*  
7 *issue a semipostal stamp (hereinafter in this Act referred*  
8 *to as the “Multinational Species Conservation Funds*  
9 *Semipostal Stamp”)* *in accordance with succeeding provi-*  
10 *sions of this section.*

11 (b) *COST.*—*The Multinational Species Conservation*  
12 *Funds Semipostal Stamp shall be offered at a cost equal*  
13 *to the cost of mailing a letter weighing 1 ounce or less at*  
14 *the nonautomation single-piece first-ounce letter rate, in ef-*  
15 *fect at the time of purchase, plus a differential of not less*  
16 *than 25 percent.*

17 (c) *OTHER TERMS AND CONDITIONS.*—*The issuance*  
18 *and sale of the Multinational Species Conservation Funds*  
19 *Semipostal Stamp shall be governed by the provisions of*  
20 *section 416 of title 39, United States Code, and regulations*  
21 *issued under such section, subject to subsection (b) and the*  
22 *following:*

23 (1) *DISPOSITION OF PROCEEDS.*—

24 (A) *IN GENERAL.*—*All amounts becoming*  
25 *available from the sale of the Multinational Spe-*  
26 *cies Conservation Funds Semipostal Stamp (as*

1           *determined under section 416(d) of such title 39)*  
2           *shall be transferred to the United States Fish*  
3           *and Wildlife Service, for the purpose described in*  
4           *subsection (a), through payments which shall be*  
5           *made at least twice a year, with the proceeds to*  
6           *be divided equally among the African Elephant*  
7           *Conservation Fund, the Asian Elephant Con-*  
8           *servation Fund, the Great Ape Conservation*  
9           *Fund, the Marine Turtle Conservation Fund, the*  
10          *Rhinoceros and Tiger Conservation Fund, and*  
11          *other international wildlife conservation funds*  
12          *authorized by the Congress after the date of the*  
13          *enactment of this Act and administered by the*  
14          *Service as part of the Multinational Species*  
15          *Conservation Fund.*

16                 *(B) PROCEEDS NOT TO BE OFFSET.—In ac-*  
17                 *cordance with section 416(d)(4) of such title 39,*  
18                 *amounts becoming available from the sale of the*  
19                 *Multinational Species Conservation Funds*  
20                 *Semipostal Stamp (as so determined) shall not*  
21                 *be taken into account in any decision relating to*  
22                 *the level of appropriations or other Federal fund-*  
23                 *ing to be furnished in any year to—*

24                         *(i) the United States Fish and Wildlife*  
25                         *Service; or*

1                   (ii) any of the funds identified in sub-  
2                   paragraph (A).

3                   (2) *DURATION.*—*The Multinational Species Con-*  
4                   *servaion Funds Semipostal Stamp shall be made*  
5                   *available to the public for a period of at least 5 years,*  
6                   *beginning no later than 12 months after the date of*  
7                   *the enactment of this Act.*

8                   (3) *STAMP DEPICTIONS.*—*Stamps issued under*  
9                   *this Act shall depict images of flagship multinational*  
10                  *species, such as African and Asian elephants, rhinoc-*  
11                  *eros and tigers, marine turtles, and certain species of*  
12                  *great apes.*

13                  (4) *LIMITATION.*—*The Multinational Species*  
14                  *Conservation Funds Semipostal Stamp shall not be*  
15                  *subject to, or taken into account for purposes of ap-*  
16                  *plying, any limitation under section 416(e)(1)(C) of*  
17                  *such title 39.*

18                  (5) *RESTRICTION ON USE OF FUNDS.*—*Amounts*  
19                  *transferred under paragraph (1) shall not be used to*  
20                  *fund or support the Wildlife Without Borders Pro-*  
21                  *gram or to supplement funds made available for the*  
22                  *Neotropical Migratory Bird Conservation Fund.*

23                  (d) *DEFINITION.*—*For purposes of this Act, the term*  
24                  *“semipostal stamp” refers to a stamp described in section*  
25                  *416(a)(1) of title 39, United States Code.*
