## A BILL

To extend certain provisions of the USA PATRIOT Act and the Intelligence Reform and Terrorism Prevention Act of 2004 for 10 years.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safe and Secure Amer-  
5 ica Act of 2009”.

1 **SEC. 2. 10-YEAR EXTENSION OF CERTAIN PROVISIONS OF**  
2 **THE USA PATRIOT ACT AND THE INTEL-**  
3 **LIGENCE REFORM AND TERRORISM PREVEN-**  
4 **TION ACT OF 2004.**

5 (a) USA PATRIOT ACT.—Section 102(b) of the  
6 USA PATRIOT Improvement and Reauthorization Act of  
7 2005 (Public Law 109–177; 120 Stat. 195) is amended  
8 by striking “December 31, 2009” and inserting “Decem-  
9 ber 31, 2019”.

10 (b) INTELLIGENCE REFORM AND TERRORISM PRE-  
11 VENTION ACT OF 2004.—Section 6001(b)(1) of the Intel-  
12 ligence Reform and Terrorism Prevention Act of 2004  
13 (Public Law 108–458; 118 Stat. 3742; 50 U.S.C. 1801  
14 note) is amended by striking “December 31, 2009” and  
15 inserting “December 31, 2019”.
