AN ACT

To make technical amendments to laws containing time periods affecting judicial proceedings.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Statutory Time-Peri-
3 ods Technical Amendments Act of 2009”.

4 **SEC. 2. AMENDMENTS RELATED TO TITLE 11, UNITED**
5 **STATES CODE.**

6 Title 11, United States Code, is amended—

7 (1) in section 109(h)(3)(A)(ii), by striking “5-
8 day” and inserting “7-day”;

9 (2) in section 322(a), by striking “five days”
10 and inserting “seven days”;

11 (3) in section 332(a), by striking “5 days” and
12 inserting “7 days”;

13 (4) in section 342(e)(2), by striking “5 days”
14 and inserting “7 days”;

15 (5) in section 521(e)(3)(B), by striking “5
16 days” and inserting “7 days”;

17 (6) in section 521(i)(2), by striking “5 days”
18 and inserting “7 days”;

19 (7) in section 704(b)(1)(B), by striking “5
20 days” and inserting “7 days”;

21 (8) in section 749(b), by striking “five days”
22 and inserting “seven days”; and

23 (9) in section 764(b), by striking “five days”
24 and inserting “seven days”.

1 **SEC. 3. AMENDMENTS RELATED TO TITLE 18, UNITED**
2 **STATES CODE.**

3 Title 18, United States Code, is amended—

4 (1) in section 983(j)(3), by striking “10 days”
5 and inserting “14 days”;

6 (2) in section 1514(a)(2)(C), by striking “10
7 days” each place it appears and inserting “14 days”;

8 (3) in section 1514(a)(2)(E), by inserting after
9 “the Government” the following: “, excluding inter-
10 mediate weekends and holidays,”;

11 (4) in section 1963(d)(2), by striking “ten
12 days” and inserting “fourteen days”;

13 (5) in section 2252A(c), by striking “10 days”
14 and inserting “14 days”;

15 (6) in section 2339B(f)(5)(B)(ii), by striking
16 “10 days” and inserting “14 days”;

17 (7) in section 2339B(f)(5)(B)(iii)(I), by insert-
18 ing after “trial” the following: “, excluding inter-
19 mediate weekends and holidays”;

20 (8) in section 2339B(f)(5)(B)(iii)(III), by in-
21 sserting after “appeal” the following: “, excluding in-
22 termediate weekends and holidays”;

23 (9) in section 3060(b)(1), by striking “tenth
24 day” and inserting “fourteenth day”;

1 (10) in section 3432, by inserting after “com-
2 mencement of trial” the following: “, excluding in-
3 termediate weekends and holidays,”;

4 (11) in section 3509(b)(1)(A), by striking “5
5 days” and inserting “7 days”; and

6 (12) in section 3771(d)(5)(B), by striking “10
7 days” and inserting “14 days”.

8 **SEC. 4. AMENDMENTS RELATED TO THE CLASSIFIED IN-**
9 **FORMATION PROCEDURES ACT.**

10 The Classified Information Procedures Act (18
11 U.S.C. App.) is amended—

12 (1) in section 7(b), by striking “ten days” and
13 inserting “fourteen days”;

14 (2) in section 7(b)(1), by inserting after “ad-
15 journment of the trial,” the following: “excluding in-
16 termediate weekends and holidays,”; and

17 (3) in section 7(b)(3), by inserting after “argu-
18 ment on appeal,” the following: “excluding inter-
19 mediate weekends and holidays,”.

20 **SEC. 5. AMENDMENT RELATED TO THE CONTROLLED SUB-**
21 **STANCES ACT.**

22 Section 413(e)(2) of the Controlled Substances Act
23 (21 U.S.C. 853(e)(2)) is amended by striking “ten days”
24 and inserting “fourteen days”.

1 **SEC. 6. AMENDMENTS RELATED TO TITLE 28, UNITED**
2 **STATES CODE.**

3 Title 28, United States Code, is amended—

4 (1) in section 636(b)(1), by striking “ten days”
5 and inserting “fourteen days”;

6 (2) in section 1453(c)(1), by striking “not less
7 than 7 days” and inserting “not more than 10
8 days”; and

9 (3) in section 2107(c), by striking “7 days” and
10 inserting “14 days”.

11 **SEC. 7. EFFECTIVE DATE.**

12 The amendments made by this Act shall take effect
13 on December 1, 2009.
