H. R. 2188

AN ACT

To authorize the Secretary of the Interior, through the United States Fish and Wildlife Service, to conduct a Joint Venture Program to protect, restore, enhance, and manage migratory bird populations, their habitats, and the ecosystems they rely on, through voluntary actions on public and private lands, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLES.**

4 This Act may be cited as the “Joint Ventures for
5 Bird Habitat Conservation Act of 2009”.

6 **SEC. 2. FINDINGS AND PURPOSE.**

7 (a) FINDINGS.—Congress finds that—

8 (1) migratory birds are of great ecological and
9 economic value to the Nation, contributing to bio-
10 biological diversity, advancing the well-being of human
11 communities through pollination, seed dispersal, and
12 other ecosystem services, and bringing tremendous
13 enjoyment to the tens of millions of Americans who
14 study, watch, feed, or hunt these birds;

15 (2) sustainable populations of migratory birds
16 depend on the conservation, protection, restoration,
17 and enhancement of terrestrial, wetland, marine,
18 and other aquatic habitats throughout their ranges
19 in the United States, as well as the rest of North
20 America, the Caribbean, and Central and South
21 America;

22 (3) birds are good indicators of environmental
23 health and provide early warning of the impacts of
24 environmental change, helping to yield the most out
25 of every dollar invested in conservation;

1 (4) human and environmental stressors are
2 causing the decline of populations of many migra-
3 tory bird species, many of them once common, and
4 climate change will exacerbate the impacts of these
5 stressors on migratory bird populations;

6 (5) the coordination of Federal, State, tribal,
7 and local government natural resource conservation
8 efforts and the formation of partnerships that in-
9 clude a diversity of nongovernmental conservation
10 organizations, private landowners, and other relevant
11 stakeholders is necessary to accomplish the conserva-
12 tion of migratory bird populations, their habitats,
13 and the ecosystem functions they rely on;

14 (6) hunters, through their purchase of Federal
15 migratory bird hunting stamps and State hunting li-
16 censes, have long supported the conservation of mi-
17 gratory birds and their habitats in the United States
18 through the various State and Federal programs
19 that are supported by the fees charged for such pur-
20 chases;

21 (7) the Department of the Interior, through the
22 United States Fish and Wildlife Service, is author-
23 ized under a number of broad statutes to undertake
24 many activities with partners to conserve natural re-
25 sources, including migratory birds and their habitat;

1 (8) through these authorities, the Service has
2 created and supported a number of joint ventures
3 with diverse partners to help protect, manage, en-
4 hance, and restore migratory bird habitat through-
5 out much of the United States and to conserve mi-
6 gratory bird species;

7 (9) the North American Waterfowl Manage-
8 ment Plan, adopted by the United States and Can-
9 ada in 1986, with Mexico joining as a signatory in
10 1994, was the first truly landscape-level approach to
11 conserving migratory game birds and the wetland
12 habitats on which they depend, and became the
13 foundation for the voluntary formation of Joint Ven-
14 tures;

15 (10) since the adoption of the North American
16 Waterfowl Management Plan, joint ventures have ex-
17 panded their application to all native birds and other
18 wildlife species that depend on wetlands and associ-
19 ated upland habitats, resulting in significant con-
20 servation benefits over the last 20 years;

21 (11) States possess broad trustee and manage-
22 ment authority over fish and wildlife resources with-
23 in their borders, and have utilized their authorities
24 to undertake conservation programs to conserve resi-
25 dent and migratory birds and their habitats;

1 (12) consistent with applicable Federal and
2 State laws, the Federal Government and the States
3 each have management responsibilities affecting fish
4 and wildlife resources, and should work cooperatively
5 in fulfilling these responsibilities;

6 (13) other domestic and international conserva-
7 tion projects authorized under the Neotropical Mi-
8 gratory Bird Conservation Act (16 U.S.C. 6101 et
9 seq.) and the North American Wetlands Conserva-
10 tion Act (16 U.S.C. 4401 et seq.), and additional
11 bird conservation projects authorized under other
12 Federal authorities, can expand and increase the ef-
13 fectiveness of the joint ventures in protecting and
14 enhancing migratory bird habitats throughout the
15 different ranges of species native to the United
16 States; and

17 (14) the voluntary partnerships fostered by
18 these joint ventures have served as innovative models
19 for cooperative and effective landscape conservation,
20 with far-reaching benefits to other fish and wildlife
21 populations, and similar joint ventures should be au-
22 thorized specifically to reinforce the importance and
23 multiple benefits of these models to encourage
24 adaptive resource management and the implementa-

1 tion of flexible conservation strategies in the 21st
2 century.

3 (b) PURPOSE.—The purpose of this Act is to estab-
4 lish a program administered by the Director, in coordina-
5 tion with other Federal agencies with management author-
6 ity over fish and wildlife resources and the States, to de-
7 velop, implement, and support innovative, voluntary, coop-
8 erative, and effective conservation strategies and conserva-
9 tion actions to—

10 (1) promote, primarily, sustainable populations
11 of migratory birds, and, secondarily, the fish and
12 wildlife species associated with their habitats;

13 (2) encourage stakeholder and government
14 partnerships consistent with the goals of protecting,
15 improving, and restoring habitat;

16 (3) establish, implement, and improve science-
17 based migratory bird conservation plans and pro-
18 mote and facilitate broader landscape-level conserva-
19 tion of fish and wildlife habitat; and

20 (4) coordinate related conservation activities of
21 the Service and other Federal agencies to maximize
22 the efficient and effective use of funds appropriated
23 or otherwise made available to support projects and
24 activities to enhance bird populations and other pop-
25 ulations of fish and wildlife and their habitats.

1 **SEC. 3. DEFINITIONS.**

2 In this Act:

3 (1) CONSERVATION ACTION.—The term “con-
4 servation action” means activities that—

5 (A) support the protection, restoration,
6 adaptive management, conservation, or en-
7 hancement of migratory bird populations, their
8 terrestrial, wetland, marine, or other habitats,
9 and other wildlife species supported by those
10 habitats, including—

11 (i) biological and geospatial planning;

12 (ii) landscape and conservation de-
13 sign;

14 (iii) habitat protection, enhancement,
15 and restoration;

16 (iv) monitoring and tracking;

17 (v) applied research; and

18 (vi) public outreach and education;

19 (B) are conducted on lands or waters
20 that—

21 (i) are administered for the long-term
22 conservation of such lands or waters and
23 the migratory birds thereon, including the
24 marine environment; or

1 (ii) are not primarily held or managed
2 for conservation but provide habitat value
3 for migratory birds; and

4 (C) incorporate adaptive management and
5 science-based monitoring, where applicable, to
6 improve outcomes and ensure efficient and ef-
7 fective use of Federal funds.

8 (2) DIRECTOR.—The term “Director” means
9 the Director of the United States Fish and Wildlife
10 Service.

11 (3) IMPLEMENTATION PLAN.—The term “Im-
12 plementation Plan” means an Implementation Plan
13 approved by the Director under section 5.

14 (4) INDIAN TRIBE.—The term “Indian tribe”
15 has the meaning given that term in section 4 of the
16 Indian Self-Determination and Education Assistance
17 Act (25 U.S.C. 450b).

18 (5) JOINT VENTURE.—The term “Joint Ven-
19 ture” means a self-directed, voluntary partnership,
20 established and conducted in accordance with section
21 5.

22 (6) MANAGEMENT BOARD.—The term “Man-
23 agement Board” means a Joint Venture Manage-
24 ment Board established in accordance with section
25 5.

1 (7) MIGRATORY BIRDS.—The term “migratory
2 birds” means those species included in the list of mi-
3 gratory birds that appears in section 10.13 of title
4 50, Code of Federal Regulations, under the author-
5 ity of the Migratory Bird Treaty Act.

6 (8) PROGRAM.—The term “Program” means
7 the Joint Ventures Program conducted in accord-
8 ance with this Act.

9 (9) SECRETARY.—The term “Secretary” means
10 the Secretary of the Interior.

11 (10) SERVICE.—The term “Service” means the
12 United States Fish and Wildlife Service.

13 (11) STATE.—The term “State” means—

14 (A) any State of the United States, the
15 District of Columbia, the Commonwealth of
16 Puerto Rico, Guam, the Virgin Islands, Amer-
17 ican Samoa, and the Commonwealth of the
18 Northern Mariana Islands; and

19 (B) one or more agencies of a State gov-
20 ernment responsible under State law for man-
21 aging fish or wildlife resources.

22 **SEC. 4. JOINT VENTURES PROGRAM.**

23 (a) IN GENERAL.—The Secretary shall conduct,
24 through the United States Fish and Wildlife Service, a
25 Joint Ventures Program administered by the Director.

1 The Director, through the Program, shall develop an ad-
2 ministrative framework for the approval and establish-
3 ment and implementation of Joint Ventures, that—

4 (1) provides financial and technical assistance
5 to support regional migratory bird conservation part-
6 nerships;

7 (2) develops and implements plans to protect
8 and enhance migratory bird populations throughout
9 their range, that are focused on regional landscapes
10 and habitats that support those populations;

11 (3) complements and supports activities by the
12 Secretary and the Director to fulfill obligations
13 under—

14 (A) the Migratory Bird Treaty Act (16
15 U.S.C. 701 et seq.);

16 (B) the Migratory Bird Conservation Act
17 (16 U.S.C. 715 et seq.);

18 (C) the Neotropical Migratory Bird Con-
19 servation Act (16 U.S.C. 6101 et seq.);

20 (D) the North American Wetlands Con-
21 servation Act (16 U.S.C. 4401 et seq.);

22 (E) the Fish and Wildlife Conservation Act
23 of 1980 (16 U.S.C. 2901 et seq.); and

24 (F) the Partners for Fish and Wildlife Act
25 (16 U.S.C. 3771 et seq.); and

1 (4) support the goals and objectives of—

2 (A) the North American Waterfowl Man-
3 agement Plan;

4 (B) the United States Shorebird Conserva-
5 tion Plan;

6 (C) the North American Waterbird Con-
7 servation Plan;

8 (D) the Partners in Flight North Amer-
9 ican Landbird Conservation Plan; and

10 (E) other treaties, conventions, agree-
11 ments, or strategies entered into by the United
12 States and implemented by the Secretary that
13 promote the conservation of migratory bird pop-
14 ulations and their habitats.

15 (b) GUIDELINES.—Within 180 days after the date of
16 enactment of this Act the Secretary, through the Director,
17 shall publish in the Federal Register guidelines for the im-
18 plementation of this Act, including regarding requirements
19 for approval of proposed Joint Ventures and administra-
20 tion, oversight, coordination among, and evaluation of ap-
21 proved Joint Ventures.

22 (c) COORDINATION WITH STATES.—In the adminis-
23 tration of the program authorized under this section, the
24 Director shall coordinate and cooperate with the States
25 to fulfill the purposes of this Act.

1 **SEC. 5. JOINT VENTURE ESTABLISHMENT AND ADMINIS-**
2 **TRATION.**

3 (a) ESTABLISHMENT.—

4 (1) IN GENERAL.—The Director, through the
5 Program, may enter into an agreement with eligible
6 partners described in paragraph (2) to establish a
7 Joint Venture to fulfill one or more of the purposes
8 set forth in paragraphs (1) through (3) of section
9 2(b).

10 (2) ELIGIBLE PARTNERS.—The eligible part-
11 ners referred to in paragraph (1) are the following:

12 (A) Federal and State agencies with juris-
13 diction over migratory bird resources, their
14 habitats, or that implement program activities
15 that affect migratory bird habitats or the eco-
16 systems they rely on.

17 (B) Affected regional, local, and tribal gov-
18 ernments, private landowners, land managers,
19 and other private stakeholders.

20 (C) Nongovernmental organizations with
21 expertise in bird conservation or fish and wild-
22 life conservation or natural resource and land-
23 scape management generally.

24 (D) Other relevant stakeholders.

25 (b) MANAGEMENT BOARD.—

1 (1) IN GENERAL.—An agreement under this
2 section for a Joint Venture shall establish a Manage-
3 ment Board in accordance with this subsection.

4 (2) MEMBERSHIP.—The Management Board
5 shall include a diversity of members representing
6 stakeholder interests from the appropriate geo-
7 graphic region, including, as appropriate, representa-
8 tives from the Service and other Federal agencies
9 that have management authority over fish and wild-
10 life resources on public lands or in the marine envi-
11 ronment, or that implement programs that affect
12 migratory bird habitats, and representatives from
13 the States, and may include—

14 (A) regional governments and Indian
15 tribes;

16 (B) academia or the scientific community;

17 (C) nongovernmental landowners or land
18 managers;

19 (D) nonprofit conservation or other rel-
20 evant organizations with expertise in migratory
21 bird conservation, or in fish and wildlife con-
22 servation generally; and

23 (E) private organizations with a dedicated
24 interest in conserving migratory birds and their
25 habitats.

1 (3) FUNCTIONS AND RESPONSIBILITIES.—

2 (A) ORGANIZATION AND OPERATIONS
3 PLAN.—A Management Board, in accordance
4 with the guidelines published by the Director
5 under section 4 and in coordination with the
6 Director, shall develop, publish, and comply
7 with a plan that specifies the organizational
8 structure of the Joint Venture and prescribes
9 its operational practices and procedures.

10 (B) ADMINISTRATION.—Subject to applica-
11 ble Federal and State law, the Management
12 Board shall manage the personnel and oper-
13 ations of the Joint Venture, including—

14 (i) by appointing a coordinator for the
15 Joint Venture in consultation with the Di-
16 rector, to manage the daily and long-term
17 operations of the Joint Venture;

18 (ii) approval of other full- or part-time
19 administrative and technical non-Federal
20 employees as the Management Board de-
21 termines necessary to perform the func-
22 tions of the Joint Venture, meet objectives
23 specified in the Implementation Plan, and
24 fulfill the purpose of this Act; and

1 (iii) establishment of committees,
2 steering groups, focus groups, geographic
3 or taxonomic groups, or other organiza-
4 tional entities to assist in implementing the
5 relevant Implementation Plan.

6 (4) USE OF SERVICE AND FEDERAL AGENCY
7 EMPLOYEES.—Subject to the availability of appro-
8 priations and upon the request from a Management
9 Board, and after consultation with and approval of
10 the Director, the head of any Federal agency may
11 detail to the Management Board, on a reimbursable
12 or nonreimbursable basis, any agency personnel to
13 assist the Joint Venture in performing its functions
14 under this Act.

15 (c) IMPLEMENTATION PLAN.—

16 (1) SUBMISSION OF PLAN TO DIRECTOR.—Be-
17 fore the Director enters into an agreement to estab-
18 lish a Joint Venture under subsection (a), the Man-
19 agement Board for the Joint Venture shall submit
20 to the Director a proposed Implementation Plan that
21 shall contain, at a minimum, the following elements:

22 (A) A strategic framework for migratory
23 bird conservation that includes biological plan-
24 ning; conservation design; habitat restoration,

1 protection, and enhancement; applied research;
2 and monitoring and evaluation activities.

3 (B) Provisions for effective communication
4 among member participants within the Joint
5 Venture.

6 (C) A long-term strategy to conduct public
7 outreach and education regarding the purposes
8 and activities of the Joint Venture and activi-
9 ties to regularly communicate to the general
10 public information generated by the Joint Ven-
11 ture.

12 (D) Coordination with laws and conserva-
13 tion plans referred to in section 4(a)(3) and (4)
14 that are relevant to migratory birds, and other
15 relevant regional, national, or international ini-
16 tiatives identified by the Director to conserve
17 migratory birds, their habitats, ecological func-
18 tions, and associated populations of fish and
19 wildlife.

20 (E) An organizational plan that—

21 (i) identifies the initial membership of
22 the Management Board and establishes
23 procedures for updating the membership of
24 the Management Board as appropriate;

1 (ii) describes the organizational struc-
2 ture of the Joint Venture, including pro-
3 posed committees and subcommittees, and
4 procedures for revising and updating the
5 structure, as necessary; and

6 (iii) provides a strategy to increase
7 stakeholder participation or membership in
8 the Joint Venture.

9 (F) Procedures to coordinate the develop-
10 ment, implementation, oversight, monitoring,
11 tracking, and reporting of conservation actions
12 approved by the Management Board and an
13 evaluation process to determine overall effec-
14 tiveness of activities undertaken by the Joint
15 Venture.

16 (G) A strategy to encourage the contribu-
17 tion of non-Federal financial resources, dona-
18 tions, gifts and in-kind contributions to support
19 the objectives of the Joint Venture and fulfill-
20 ment of the Implementation Plan.

21 (2) REVIEW.—The Director shall—

22 (A) coordinate the review of a proposed
23 Implementation Plan submitted under this sec-
24 tion; and

1 (B) ensure that such plan is circulated for
2 review for a period not to exceed 90 days, to—

3 (i) bureaus within the Service and
4 other appropriate bureaus or agencies
5 within the Department of the Interior;

6 (ii) appropriate regional migratory
7 bird Flyway Councils;

8 (iii) national and international boards
9 that oversee bird conservation initiatives
10 under the plans specified in section
11 4(a)(4);

12 (iv) relevant State agencies, regional
13 governmental entities, and Indian tribes;

14 (v) nongovernmental conservation or-
15 ganizations, academic institutions, or other
16 stakeholders engaged in existing Joint
17 Ventures that have knowledge or expertise
18 of the geographic or ecological scope of the
19 Joint Venture; and

20 (vi) other relevant stakeholders con-
21 sidered necessary by the Director to ensure
22 a comprehensive review of the proposed
23 Implementation Plan.

24 (3) APPROVAL.—The Director shall approve an
25 Implementation Plan submitted by the Management

1 Board for a Joint Venture if the Director finds
2 that—

3 (A) the plan provides for implementation
4 of conservation actions to conserve waterfowl
5 and other native migratory birds and their
6 habitats and ecosystems either—

7 (i) in a specific geographic area of the
8 United States; or

9 (ii) across the range of a specific spe-
10 cies or similar group of like species;

11 (B) the members of the Joint Venture—

12 (i) accept the responsibility for imple-
13 mentation of national or international bird
14 conservation plans in the region of the
15 United States to which the plan applies;
16 and

17 (ii) have demonstrated to the satisfac-
18 tion of the Director the capacity to imple-
19 ment conservation actions identified in the
20 plan, including (I) the design, funding,
21 monitoring, and tracking of conservation
22 projects that advance the objectives of the
23 Joint Venture; and (II) reporting and con-
24 duct of public outreach regarding such
25 projects; and

1 (C) the plan maximizes, to the extent prac-
2 ticable, coordination with other relevant and ac-
3 tive conservation plans or programs within the
4 geographic scope of the Joint Venture to con-
5 serve, protect, recover, or restore migratory bird
6 habitats and other fish and wildlife habitat
7 within the operating region of the Joint Ven-
8 ture.

9 **SEC. 6. GRANTS AND OTHER ASSISTANCE.**

10 (a) IN GENERAL.—Except as provided in subsection
11 (b), and subject to the availability of appropriations, the
12 Director may award grants of financial assistance to im-
13 plement a Joint Venture through—

14 (1) support of the activities of the Management
15 Board of the Joint Venture and to pay for necessary
16 administrative costs and services, personnel, and
17 meetings, travel, and other business activities; and

18 (2) support for specific conservation actions and
19 other activities necessary to carry out the Implemen-
20 tation Plan.

21 (b) LIMITATION.—A Joint Venture is not eligible for
22 assistance or support authorized in this section unless the
23 Joint Venture is operating under an Implementation Plan
24 approved by the Director under section 5.

1 (c) CONSERVATION ACTION GRANT CRITERIA.—The
2 Secretary, through the Director, within 180 days after
3 date of enactment of this Act and after consultation with
4 representatives from Management Boards and equivalent
5 entities of joint ventures referred to in section 8, shall
6 publish guidelines for determining funding allocations
7 among joint ventures and priorities for funding among
8 conservation action proposals to meet the purpose of this
9 Act and respective Implementation Plans.

10 (d) MATCHING REQUIREMENTS.—If a Management
11 Board determines that two or more proposed conservation
12 actions are of equal value toward fulfillment of the rel-
13 evant Implementation Plan, priority shall be given to the
14 action or actions for which there exist non-Federal match-
15 ing contributions that are equal to or exceed the amount
16 of Federal funds available for such action or actions.

17 (e) TECHNICAL ASSISTANCE.—The Secretary,
18 through the Director, may provide technical and adminis-
19 trative assistance for implementation of Joint Ventures
20 and the expenditure of financial assistance under this sub-
21 section.

22 (f) ACCEPTANCE AND USE OF DONATIONS.—The
23 Secretary, through the Director, may accept and use dona-
24 tions of funds, gifts, and in-kind contributions to provide
25 assistance under this section.

1 **SEC. 7. REPORTING REQUIREMENTS.**

2 (a) ANNUAL REPORTS BY MANAGEMENT BOARDS.—

3 (1) IN GENERAL.—The Secretary, acting
4 through the Director, shall—

5 (A) require each Management Board to
6 submit annual reports for all approved Joint
7 Ventures of the Management Board; and

8 (B) publish within 180 days after the date
9 of enactment of this Act guidelines to imple-
10 ment this subsection.

11 (2) CONTENTS.—Each annual report shall in-
12 clude—

13 (A) a description and justification of all
14 conservation actions approved and implemented
15 by the Management Board during the period
16 covered by the report;

17 (B) when appropriate based upon the goals
18 and objectives of an Implementation Plan, an
19 estimate of the total number of acres of migra-
20 tory bird habitat either restored, protected, or
21 enhanced as a result of such conservation ac-
22 tions;

23 (C) the amounts and sources of Federal
24 and non-Federal funding for such conservation
25 actions;

1 (D) the amounts and sources of funds ex-
2 pended for administrative and other expenses of
3 the Joint Venture of the Management Board,
4 including all donations, gifts, and in-kind con-
5 tributions provided for the Joint Venture;

6 (E) the status of progress made in achiev-
7 ing the strategic framework of the Implementa-
8 tion Plan of such Joint Venture and fulfillment
9 of the purpose of this Act; and

10 (F) other elements considered necessary by
11 the Director to insure transparency and ac-
12 countability by Management Boards in the im-
13 plementation of its responsibilities under this
14 Act.

15 (b) JOINT VENTURE PROGRAM 5-YEAR REVIEWS.—

16 (1) IN GENERAL.—The Secretary, acting
17 through the Director, shall at 5 years after the date
18 of enactment of this Act and at 5-year intervals
19 thereafter, complete an objective and comprehensive
20 review and evaluation of the Program.

21 (2) REVIEW CONTENTS.—Each review under
22 this subsection shall include—

23 (A) an evaluation of the effectiveness of
24 the Program in meeting the purpose of this Act
25 specified in section 2(b);

1 (B) an evaluation of all approved Imple-
2 mentation Plans, especially the effectiveness of
3 existing conservation strategies, priorities, and
4 methods to meet the objectives of such plans
5 and fulfill the purpose of this Act; and

6 (C) recommendations to revise the Pro-
7 gram or to amend or otherwise revise Imple-
8 mentation Plans to ensure that activities under-
9 taken pursuant to this Act address the effects
10 of climate change on migratory bird populations
11 and their habitats, and fish and wildlife habi-
12 tats, in general.

13 (3) CONSULTATION.—The Secretary, acting
14 through the Director, in the implementation of this
15 subsection—

16 (A) shall consult with other appropriate
17 Federal agencies with responsibility for the con-
18 servation or management of fish and wildlife
19 habitat and appropriate State agencies; and

20 (B) may consult with appropriate, Indian
21 tribes, Flyway Councils, or regional conserva-
22 tion organizations, public and private land-
23 owners, members of academia and the scientific
24 community, and other nonprofit conservation or
25 private stakeholders.

1 (4) PUBLIC COMMENT.—The Secretary,
2 through the Director, shall provide for adequate op-
3 portunities for general public review and comment of
4 the Program as part of the 5-year evaluations con-
5 ducted pursuant to this subsection.

6 **SEC. 8. TREATMENT OF EXISTING JOINT VENTURES.**

7 For purposes of this Act, the Director—

8 (1) shall treat as a Joint Venture any joint ven-
9 ture recognized by the Director before the date of
10 the enactment of this Act in accordance with the
11 United States Fish and Wildlife Services manual
12 (721FW6); and

13 (2) shall treat as an Implementation Plan an
14 implementation plan adopted by the management
15 board for such joint venture.

16 **SEC. 9. RELATIONSHIP TO OTHER AUTHORITIES.**

17 (a) AUTHORITIES, ETC. OF SECRETARY.—Nothing in
18 this Act affects authorities, responsibilities, obligations, or
19 powers of the Secretary under any other Act.

20 (b) STATE AUTHORITY.—Nothing in this Act pre-
