## A BILL

To establish certain requirements relating to the provision of services to minors by family planning projects under title X of the Public Health Service Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Parent’s Right to  
5 Know Act of 2009”.

1 **SEC. 2. PROVISIONS REGARDING TITLE X FAMILY PLAN-**  
2 **NING PROJECTS.**

3 (a) PROVISION OF CONTRACEPTIVE DRUGS OR PRE-  
4 SCRIPTION DEVICES TO MINORS.—None of the funds ap-  
5 propriated in any Federal Act for any fiscal year for car-  
6 rying out title X of the Public Health Service Act (42  
7 U.S.C. 300 et seq.) may be made available to any family  
8 planning project under section 1001 of such title if any  
9 provider of services in the project knowingly provides con-  
10 traceptive drugs or prescription devices to a minor, un-  
11 less—

12 (1) such provider of services has given actual  
13 written notice to a custodial parent or custodial legal  
14 guardian of the minor, notifying the parent or legal  
15 guardian of the intent to provide the drugs or pre-  
16 scription devices, at least five business days before  
17 providing the drugs or prescription devices;

18 (2) the minor has the written consent of a cus-  
19 todial parent or custodial legal guardian to receive  
20 the drugs or prescription devices;

21 (3) the minor is emancipated under applicable  
22 State law; or

23 (4) a court of competent jurisdiction has di-  
24 rected that the minor may receive the drugs or pre-  
25 scription devices.

1           (b) CERTIFICATION OF COMPLIANCE.—Each provider  
2 of services under section 1001 of title X of the Public  
3 Health Service Act shall each year certify to the Secretary  
4 of Health and Human Services compliance with this sec-  
5 tion. Such Secretary shall prescribe such regulations as  
6 may be necessary to effectuate this section.
