To amend title 38, United States Code, to provide support services for family caregivers of disabled veterans, and for other purposes.

Mrs. Halvorson introduced the following bill; which was referred to the Committee on Veterans' Affairs

## A BILL

To amend title 38, United States Code, to provide support services for family caregivers of disabled veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Wounded Warrior
- 5 Caregiver Assistance Act".
- 6 SEC. 2. SUPPORT SERVICES FOR FAMILY CAREGIVERS.
- 7 (a) In General.—Chapter 17 of title 38, United
- 8 States Code, is amended by adding at the end the fol-
- 9 lowing new section:

## 1 "§ 1786. Support services for family caregivers

2	"(a) Training.—The Secretary shall make available
3	interactive training sessions for family caregivers and indi-
4	viduals who provide such caregivers support under this
5	chapter or through the aging network (including respite
6	care providers, nursing care providers, and counselors).
7	Such training shall—
8	"(1) be made available both in person and on
9	an Internet website;
10	"(2) incorporate telehealth technologies to the
11	extent practicable; and
12	"(3) teach techniques, strategies, and skills for
13	caring for a disabled veteran, including, at a min-
14	imum, effective methods of—
15	"(A) caring for a veteran—
16	"(i) with post-traumatic stress dis-
17	order or a traumatic brain injury; and
18	"(ii) who was deployed in support of
19	Operation Enduring Freedom or Operation
20	Iraqi Freedom; and
21	"(B) recording details regarding the health
22	of the veteran.
23	"(b) Access to Support Services.—The Secretary
24	shall provide family caregivers with information con-
25	cerning public, private, and non-profit agencies that offer

1	support to such caregivers. In providing such information,
2	the Secretary shall—
3	"(1) collaborate with the Assistant Secretary
4	for Aging of the Department of Health and Human
5	Services in order to provide family caregivers access
6	to Aging and Disability Resource Centers under the
7	Administration on Aging of the Department of
8	Health and Human Services; and
9	"(2) contract with a private entity to provide
10	family caregivers with an Internet-based service that
11	contains—
12	"(A) a directory of services available at the
13	county level;
14	"(B) message boards and other similar
15	tools that provide family caregivers with the
16	ability to interact with each other and disabled
17	veterans for the purpose of fostering peer sup-
18	port and creating support networks; and
19	"(C) comprehensive information explaining
20	health-related topics and issues relevant to the
21	needs of disabled veterans and family care-
22	givers.
23	"(c) Information and Outreach.—The Secretary
24	shall conduct outreach to inform disabled veterans and the

1	families of such veterans of the services under this section.
2	Such outreach shall include the following:
3	"(1) Public service announcements.
4	"(2) Brochures and pamphlets.
5	"(3) Full use of Internet-based outreach meth-
6	ods, including—
7	"(A) participating on social networking
8	websites;
9	"(B) methods designed specifically for
10	rural families; and
11	"(C) establishing a web page on the Inter-
12	net website of the Department that—
13	"(i) is dedicated to caregiver support;
14	and
15	"(ii) contains interactive elements, in-
16	cluding providing information based on the
17	location of the person using the web page.
18	"(d) Definitions.—In this section:
19	"(1) The term 'aging network' has the meaning
20	given that term in section 102(5) of the Older Amer-
21	icans Act of 1965 (42 U.S.C. 3002(5)).
22	"(2) The term 'caregiver services' means non-
23	institutional extended care (as used in section
24	1701(6) of this title), including homemaker and
25	home health aid services.

1	"(3) The term 'family caregiver' means an indi-
2	vidual who—
3	"(A) is a member of the family (including
4	parents, spouses, children, siblings, step-family
5	members, and extended family members) of a
6	disabled veteran;
7	"(B) provides caregiver services to such
8	veteran for such disability; and
9	"(C) may or may not reside with such vet-
10	eran.''.
