#### AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2010, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Legislative Branch for the fiscal year ending September
- 6 30, 2010, and for other purposes, namely:

4	For salaries and expenses of the House of Represent-
5	atives, \$1,375,200,000, as follows:

8	\$25,881,000, including: Office of the Speaker,
9	\$5,077,000, including $$25,000$ for official expenses of the

- 4 For compensation and expenses of officers and em-
- 5 ployees, as authorized by law, \$200,301,000, including:
- 6 for salaries and expenses of the Office of the Clerk, includ-
- 7 ing not more than \$23,000, of which not more than
- 8 \$20,000 is for the Family Room, for official representa-
- 9 tion and reception expenses, \$32,089,000 of which
- 10 \$4,600,000 shall remain available until expended; for sala-
- 11 ries and expenses of the Office of the Sergeant at Arms,
- 12 including the position of Superintendent of Garages, and
- 13 including not more than \$3,000 for official representation
- 14 and reception expenses, \$9,509,000; for salaries and ex-
- 15 penses of the Office of the Chief Administrative Officer
- 16 including not more than \$3,000 for official representation
- 17 and reception expenses, \$130,782,000, of which
- 18 \$3,937,000 shall remain available until expended; for sala-
- 19 ries and expenses of the Office of the Inspector General,

- 22 \$4,445,000, to remain available until expended; for sala-
- 23 ries and expenses of the Office of General Counsel,
- 24 \$1,415,000; for the Office of the Chaplain, \$179,000; for
- 25 salaries and expenses of the Office of the Parliamentarian,

- 1 including the Parliamentarian, \$2,000 for preparing the
- 2 Digest of Rules, and not more than \$1,000 for official rep-
- 3 resentation and reception expenses, \$2,060,000; for sala-
- 4 ries and expenses of the Office of the Law Revision Coun-
- 5 sel of the House, \$3,258,000; for salaries and expenses
- 6 of the Office of the Legislative Counsel of the House,
- 7 \$8,814,000; for salaries and expenses of the Office of
- 8 Interparliamentary Affairs, \$859,000; for other author-
- 9 ized employees, \$1,249,000; and for salaries and expenses
- 10 of the Office of the Historian, including the cost of the
- 11 House Fellows Program (including lodging and related ex-
- 12 penses for visiting Program participants), \$597,000.

- 12 CHILD CARE CENTER
- For salaries and expenses of the House of Represent-
- 14 atives Child Care Center, such amounts as are deposited
- 15 in the account established by section 312(d)(1) of the Leg-
- 16 islative Branch Appropriations Act, 1992 (2 U.S.C. 2062),
- 17 subject to the level specified in the budget of the Center,
- 18 as submitted to the Committee on Appropriations of the
- 19 House of Representatives.

- 21 Sec. 101. (a) Requiring Amounts Remaining in
- 22 Members' Representational Allowances To Be
- 23 Used for Deficit Reduction or To Reduce the
- 24 Federal Debt.—Notwithstanding any other provision of
- 25 law, any amounts appropriated under this Act for

- 1 "HOUSE OF REPRESENTATIVES—SALARIES AND
- 2 Expenses—Members' Representational Allow-
- 3 ANCES" shall be available only for fiscal year 2010. Any
- 4 amount remaining after all payments are made under such
- 5 allowances for fiscal year 2010 shall be deposited in the
- 6 Treasury and used for deficit reduction (or, if there is no
- 7 Federal budget deficit after all such payments have been
- 8 made, for reducing the Federal debt, in such manner as
- 9 the Secretary of the Treasury considers appropriate).
- 10 (b) REGULATIONS.—The Committee on House Ad-
- 11 ministration of the House of Representatives shall have
- 12 authority to prescribe regulations to carry out this section.

- 17 Sec. 102. Effective with respect to fiscal year 2010
- 18 and each succeeding fiscal year, the aggregate amount

- 17 Sec. 1203. Support and Maintenance During
