- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Caregiver Assistance
3	and Resource Enhancement Act".
4	SEC. 2. SUPPORT SERVICES FOR CAREGIVERS.
5	(a) Definitions.—Section 1701 of title 38, United
6	States Code, is amended by adding at the end the fol-
7	lowing new paragraphs:
8	"(10) The term 'caregiver services' means non-
9	institutional extended care (as used in paragraph
10	(6)).
11	"(11) The term 'caregiver' means an individual
12	who—
13	"(A) with respect to a disabled veteran
14	who is enrolled in the health care system estab-
15	lished under section 1705(a) of this title, pro-
16	vides caregiver services to such veteran for such
17	disability; and
18	"(B) is not a member of the family (in-
19	cluding parents, spouses, children, siblings,
20	step-family members, and extended family
21	members) of such veteran.
22	"(12) The term 'family caregiver' means an in-
23	dividual who—
24	"(A) with respect to a disabled veteran
25	who is enrolled in the health care system estab-
26	lished under section 1705(a) of this title, pro-

1	vides caregiver services to such veteran for such
2	disability;
3	"(B) is a member of the family (including
4	parents, spouses, children, siblings, step-family
5	members, and extended family members) of
6	such veteran; and
7	"(C) may or may not reside with such vet-
8	eran.".
9	(b) Support Services.—
10	(1) IN GENERAL.—Subchapter II of chapter 17
11	of title 38, United States Code, is amended by add-
12	ing at the end the following new section:

3	"(b) Educational Sessions.—(1) The Secretary
4	shall make available educational sessions for caregivers,
5	family caregivers, and individuals described in paragraph
6	(2). Such educational sessions shall—
7	"(A) be made available both in person and on
8	an Internet website;
9	"(B) incorporate available technology, including
10	telehealth technology to the extent practicable; and
11	"(C) teach techniques, strategies, and skills for
12	caring for a disabled veteran, including, at a min-
13	imum, a veteran who—
14	"(i) was deployed in support of Operation
15	Enduring Freedom or Operation Iraqi Free-
16	dom; and
17	"(ii) has post-traumatic stress disorder, a
18	traumatic brain injury, or other severe injury or
19	illness.
20	"(2) Individuals described in this paragraph are indi-
21	viduals who provide caregivers and family caregivers with
22	support under this chapter or through an aging network
23	(as defined in section 102(5) of the Older Americans Act
24	of 1965 (42 U.S.C. 3002(5)), including—
25	"(A) respite care providers:

1	"(B) nursing care providers; and
2	"(C) counselors.
3	"(c) Stipends.—(1) The Secretary shall provide
4	monthly stipends to eligible family caregivers described in
5	paragraph (2).
6	"(2) An eligible family caregiver described in this
7	paragraph is a family caregiver who—
8	"(A) provides caregiver services to a veteran
9	who—
10	"(i) was deployed in support of Operation
11	Enduring Freedom or Operation Iraqi Free-
12	dom; and
13	"(ii) for purposes of this subsection, is de-
14	termined by the Secretary—
15	"(I) to have a service-connected dis-
16	ability or illness that is severe;
17	"(II) to be in need of caregiver serv-
18	ices, such that without such services, the
19	veteran would require hospitalization, nurs-
20	ing home care, or other residential institu-
21	tional care; and
22	"(III) based on an examination by a
23	physician employed by the Department (or
24	in areas where no such physician is avail-
25	able, by a physician carrying out such

1	function under a contract or fee arrange-
2	ment), to be unable to carry out the activi-
3	ties (including instrumental activities) of
4	daily living;
5	"(B) with respect to such veteran, meets the
6	definition of the term 'family caregiver' under sec-
7	tion 1701(12) of this title;
8	"(C) is designated by such veteran as the pri-
9	mary family caregiver for such veteran; and
10	"(D) is not—
11	"(i) employed by a home health care agen-
12	cy to provide such caregiver services; or
13	"(ii) otherwise receiving payment for such
14	services.
15	"(3) The authority of the Secretary to provide a sti-
16	pend to an eligible family caregiver under this subsection
17	shall expire on October 1, 2012.
18	"(d) Access to Support Services.—The Sec-
19	retary shall provide caregivers and family caregivers with
20	information concerning public, private, and non-profit
21	agencies that offer support to caregivers. In providing
22	such information, the Secretary shall—
23	"(1) collaborate with the Assistant Secretary
24	for Aging of the Department of Health and Human
25	Services in order to provide caregivers and family

1	caregivers access to aging and disability resource
2	centers under the Administration on Aging of the
3	Department of Health and Human Services; and
4	"(2) include on an Internet website that is dedi-
5	cated to caregivers and family caregivers—
6	"(A) a directory of services available for
7	caregivers and family caregivers at the county
8	level; and
9	"(B) tools that provide caregivers and fam-
10	ily caregivers with the ability to interact with
11	each other for the purpose of fostering peer
12	support and creating support networks.
13	"(e) Information and Outreach.—(1) The Sec-
14	retary shall conduct outreach to inform disabled veterans
15	and the families of such veterans of the following:
16	"(A) Medical care, educational sessions, sti-
17	pends, and other services available for caregivers
18	and family caregivers under this chapter.
19	"(B) The ability of a family caregiver to be
20	trained and certified by a home health care agency
21	in order to be paid by such agency for providing
22	caregiver services.
23	"(2) Outreach under this subsection shall include, at
24	a minimum, the following:
25	"(A) Public service announcements.

- 1 "(B) Brochures and pamphlets.
- 2 "(C) Full use of Internet-based outreach meth-
- ods, including such methods designed specifically for
- 4 veterans and the families of such veterans who re-
- 5 side in rural areas.
- 6 "(3) With respect to a Department employee pro-
- 7 viding case management services (as defined in section
- 8 1720C(b)(2) of this title) to a disabled veteran, the Sec-
- 9 retary shall ensure that such employee provides a care-
- 10 giver or family caregiver of such veteran with information
- 11 on the services described in subparagraphs (A) and (B)
- 12 of paragraph (1).".
- 13 (2) CLERICAL AMENDMENT.—The table of sec-
- tions at the beginning of chapter 17 of title 38,
- 15 United States Code, is amended by inserting after
- the item related to section 1720F the following new
- 17 item:

"1720G. Support services for caregivers and family caregivers.".

- 18 (c) Plan.—Not later than 180 days after the date
- 19 of the enactment of this Act, the Secretary shall submit
- 20 to the Committee on Veterans' Affairs of the House of
- 21 Representatives and the Committee on Veterans' Affairs
- 22 of the Senate a plan for carrying out section 1720G of
- 23 title 38, United States Code, as added by subsection (b)
- 24 of this section.

1	(d) REPORTS.—Not later than 180 days after the
2	date on which the plan is submitted under subsection (c)
3	and annually thereafter for the following five years, the
4	Secretary shall submit to the Committee on Veterans' Af-
5	fairs of the House of Representatives and the Committee
6	on Veterans' Affairs of the Senate a report describing the
7	implementation of the plan.
8	SEC. 3. COUNSELING AND MENTAL HEALTH SERVICES FOR
9	CAREGIVERS AND FAMILY CAREGIVERS.
10	(a) In General.—Section 1782 of title 38, United
11	States Code, is amended—
12	(1) in the section heading, by adding at the end
13	the following: ", caregivers, and family care-
14	givers"; and
15	(2) in subsection (c)—
16	(A) in paragraph (1), by striking "; or"
17	and inserting a semicolon;
18	(B) by redesignating paragraph (2) as
19	paragraph (3); and
20	(C) by inserting after paragraph (1) the
21	following new paragraph (2):
22	"(2) a caregiver or family caregiver of a vet-
23	eran; or''.
24	(b) CLERICAL AMENDMENT.—The table of sections
2.5	at the beginning of chapter 17 of title 38. United States

1	Code, is amended by striking the item relating to section
2	1782 and inserting the following new item:
	"1782. Counseling, training, and mental health services for immediate family members, caregivers, and family caregivers.".
3	SEC. 4. RESPITE CARE TO ASSIST FAMILY CAREGIVERS.
4	Section 1720B of title 38, United States Code, is
5	amended—
6	(1) in subsection (a), by striking "title." and in-
7	serting "title or who receives care from a family
8	caregiver."; and
9	(2) by adding at the end the following new sub-
10	section:
11	"(d) In furnishing respite care services under this
12	section, the Secretary shall ensure that such services—
13	"(1) fulfill the needs of the veteran receiving
14	care (including 24-hour in-home respite care); and
15	"(2) are appropriate for the veteran with re-
16	spect to the age of the veteran.".
17	SEC. 5. MEDICAL CARE FOR FAMILY CAREGIVERS.
18	Section 1781 of title 38, United States Code, is
19	amended—
20	(1) in subsection (a)—
21	(A) in paragraph (2), by striking "and" at
22	the end;
23	(B) in paragraph (3), by inserting "and"
24	at the end; and

1	(C) by inserting after paragraph (3) the
2	following new paragraph:
3	"(4) in accordance with subsection (e), a family
4	caregiver,";
5	(2) in the third sentence of subsection (b), by
6	striking "dependent or survivor" and inserting "de-
7	pendent, survivor, or family caregiver"; and
8	(3) by adding at the end the following new sub-
9	section:
10	"(e)(1) The Secretary shall provide medical care to
11	a family caregiver under this section if the Secretary de-
12	termines that the family caregiver is not entitled to care
13	or services under a health-plan contract as defined under
14	section 1725(f)(2) of this title (determined, in the case
15	of a health-plan contract as defined in subsection (f)(2)(B)
16	or (f)(2)(C) of such section, without regard to any require-
17	ment or limitation relating to eligibility for care or services
18	from any department or agency of the United States).
19	"(2) In this subsection, a family caregiver is an indi-
20	vidual who—
21	"(A) provides caregiver services to a veteran
22	who—
23	"(i) was deployed in support of Operation
24	Enduring Freedom or Operation Iraqi Free-
25	dom; and

1	"(ii) for purposes of this subsection, is de-
2	termined by the Secretary—
3	"(I) to have a service-connected dis-
4	ability or illness that is severe;
5	"(II) to be in need of caregiver serv-
6	ices, such that without such services, the
7	veteran would require hospitalization, nurs-
8	ing home care, or other residential institu-
9	tional care; and
10	"(III) based on an examination by a
11	physician employed by the Department (or,
12	in areas where no such physician is avail-
13	able, by a physician carrying out such
14	function under a contract or fee arrange-
15	ment), to be unable to carry out the activi-
16	ties (including instrumental activities) of
17	daily living;
18	"(B) with respect to such veteran, meets the
19	definition of the term 'family caregiver' under sec-
20	tion 1701(12) of this title; and
21	"(C) is designated by such veteran as the pri-
22	mary family caregiver for such veteran.
23	"(3) The authority of the Secretary to provide med-
24	ical care to a family caregiver under this section shall ex-
25	pire on October 1, 2012.".

1	SEC. 6. LODGING AND SUBSISTENCE FOR FAMILY CARE-
2	GIVERS.
3	Section 111(e) of title 38, United States Code, is
4	amended—
5	(1) by striking "When" and inserting the fol-
6	lowing: "(1) Except as provided in paragraph (2),
7	when"; and
8	(2) by adding at the end the following new
9	paragraphs:
10	"(2) Without regard to whether a covered veteran en-
11	titled to mileage under this section requires an attendant
12	in order to perform such travel, an attendant of such cov-
13	ered veteran may be allowed expenses of travel (including
14	lodging and subsistence) upon the same basis as such vet-
15	eran during—
16	"(A) the period of time in which such veteran
17	is traveling to and from a treatment facility; and
18	"(B) the duration of the treatment episode for
19	such veteran.
20	"(3) The Secretary may prescribe regulations to
21	carry out this subsection. Such regulations may include
22	provisions—
23	"(A) to limit the number of attendants that
24	may receive expenses of travel under paragraph (2)
25	for a single treatment episode of a covered veteran;
26	and

1	"(B) to require such attendants to use certain
2	travel services.
3	"(4) In this subsection, the term 'covered veteran'
4	means a veteran who—
5	"(A) was deployed in support of Operation En-
6	during Freedom or Operation Iraqi Freedom; and
7	"(B) for purposes of this subsection, is deter-
8	mined by the Secretary—
9	"(i) to have a service-connected disability
10	or illness that is severe;
11	"(ii) to be in need of caregiver services,
12	such that without such services, the veteran
13	would require hospitalization, nursing home
14	care, or other residential institutional care; and
15	"(iii) based on an examination by a physi-
16	cian employed by the Department (or, in areas
17	where no such physician is available, by a phy-
18	sician carrying out such function under a con-
19	tract or fee arrangement), to be unable to carry
20	out the activities (including instrumental activi-
21	ties) of daily living.".
22	SEC. 7. SURVEY ON CAREGIVERS AND FAMILY CARE-
23	GIVERS.
24	(a) In General.—Not later than 270 days after the
25	date of the enactment of this Act, and not less than once

1	in each three-year period thereafter, the Secretary of Vet-
2	erans Affairs shall design and conduct a survey of care-
3	givers and family caregivers. In carrying out the survey,
4	the Secretary shall collect the following information:
5	(1) The number of caregivers.
6	(2) The number of family caregivers.
7	(3) The number of veterans receiving caregiver
8	services from caregivers and family caregivers, in-
9	cluding the era in which each veteran served in the
10	Armed Forces.
11	(4) The range of caregiver services provided by
12	caregivers and family caregivers, including—
13	(A) the average schedule of such services
14	and
15	(B) the average amount of time a caregiver
16	and family caregiver has spent providing such
17	services.
18	(5) The average age of a caregiver and family
19	caregiver.
20	(6) The health care coverage of caregivers and
21	family caregivers, including the sources of such cov-
22	erage.
23	(7) The employment status of caregivers and
24	family caregivers.

- 1 (8) Incidents of significant life changes related 2 to being a caregiver or family caregiver, including 3 unemployment and disenrollment from a course of 4 education.
- 5 (9) The number of family caregivers trained 6 and certified through a home health care agency.
- 7 (10) Other information the Secretary considers 8 appropriate.
- 9 (b) Survey Sample.—In carrying out the survey re-10 quired by subsection (a), the Secretary shall ensure that—
- 11 (1) a statistically representative sample of care-12 givers and family caregivers is included in the sur-13 vey; and
- 14 (2) such sample covers veterans in each Vet-15 erans Integrated Service Network.
- 16 (c) FINDINGS.—The Secretary shall consider the 17 findings of the survey when carrying out programs related 18 to caregivers and family caregivers.
- 19 (d) Reports.—Not later than 180 days after the
- 20 date on which each survey is completed, the Secretary
- 21 shall submit to the Committee on Veterans' Affairs of the
- 22 House of Representatives and the Committee on Veterans'
- 23 Affairs of the Senate a report on caregivers and family
- 24 caregivers. Each such report shall include—

1	(1) the findings of the survey required by sub-
2	section (a);
3	(2) a summary of the services made available to
4	caregivers and family caregivers by the Secretary;
5	(3) the number of caregivers and family care-
6	givers who receive such services;
7	(4) the cost to the Department of Veterans Af-
8	fairs of providing each such service; and
9	(5) other information the Secretary considers
10	appropriate.
11	(e) Definitions.—In this section:
12	(1) The term "caregiver" has the meaning
13	given such term in section 1701(11) of title 38,
14	United States Code, as added by section 2(a) of this
15	Act.
16	(2) The term "family caregiver" has the mean-
17	ing given such term in section 1701(12) of title 38,
18	United States Code, as added by section 2(a) of this
19	Act.
