## A BILL

To direct the Secretary of Agriculture to convey to Miami-Dade County certain federally owned land in Florida, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 3 SECTION 1. DEFINITIONS.

- 4 As used in this Act:
- 5 (1) COUNTY.—The term "County" means
- 6 Miami-Dade County in the State of Florida.
- 7 (2) Secretary.—The term "Secretary" means
- 8 the Secretary of Agriculture.
- 9 (3) Property.—The term "Property" means
- approximately 2.0 acres, more or less, of the feder-
- ally owned land comprising the Subtropical Horti-
- culture Research Station in Miami-Dade County,
- 13 Florida, as described in section 2(b).

#### 14 SEC. 2. LAND CONVEYANCE.

- 15 (a) In General.—Upon receipt of the consideration
- 16 and cost reimbursement provided herein, the Secretary
- 17 shall convey and quitclaim to the County, all right, title,
- 18 and interest of the United States in the Property, subject
- 19 to easements and rights-of-way of record and such other
- 20 terms and conditions as the Secretary may prescribe.
- 21 (b) Property Delineation.—Of the federally
- 22 owned land comprising the Subtropical Horticulture Re-
- 23 search Station, the Secretary and the authorized rep-
- 24 resentative of the County shall mutually delineate 2.0

- 1 acres, more or less, fronting on SW 67th Avenue for con-
- 2 veyance as the Property.
- 3 (c) Consideration.—
- 4 (1) IN GENERAL.—As consideration for the conveyance of the Property, the County shall pay to the
- 6 Secretary an amount in cash equal to the market
- 7 value of the property.
- 8 (2) Determination of value.—To determine
- 9 the market value of the property, the Secretary shall
- 10 have the Property appraised in conformity with the
- 11 Uniform Appraisal Standards for Federal Land Ac-
- quisitions. The approved appraisal shall at all times
- be the property of the United States.
- 14 (d) Survey.—The County shall, at its cost, survey
- 15 the exterior boundaries of the Subtropical Horticulture
- 16 Research Station and the Property to Federal survey
- 17 standards to the satisfaction of the Secretary, and shall
- 18 provide to the Secretary certified originals with signature
- 19 and raised seal.
- 20 (e) Release.—The County, by a recordable instru-
- 21 ment satisfactory to the Secretary, shall release the United
- 22 States Department of Agriculture from that instrument
- 23 dated September 8, 2006, titled "Unity of Title".
- 24 (f) Time of Conveyance.—The Secretary shall con-
- 25 vey the Property to the County not later than 120 days

- 1 after the date on which the County deposits the consider-
- 2 ation with the Department of Agriculture.
- 3 (g) Corrections.—With the agreement of the
- 4 County, the Secretary may make minor corrections or
- 5 modifications to the legal description of the Property.
- 6 SEC. 3. COSTS.
- 7 (a) Transaction Costs.—At closing for the convey-
- 8 ance of the Property under this Act, the County shall pay
- 9 or reimburse the Secretary, as appropriate, for the reason-
- 10 able transaction and administrative personnel costs associ-
- 11 ated with the conveyance authorized by this Act, including
- 12 the transaction costs of appraisal, title, hazardous sub-
- 13 stances examination, and closing costs.
- 14 (b) Administrative Costs.—In addition to trans-
- 15 action costs under subsection (a), the County shall pay
- 16 administrative costs in the liquidated amount of \$50,000.
- 17 (c) Attorneys' Fees.—The County and the Sec-
- 18 retary shall each bear their own attorneys' costs.
- 19 SEC. 4. RECEIPTS.
- The Secretary shall deposit the consideration and re-
- 21 ceipts for costs into the Treasury of the United States to
- 22 be credited to the appropriation for the Agricultural Re-
- 23 search Service, and such sum shall be available to the Sec-
- 24 retary until expended, without further appropriation, for

- 1 the operation, upkeep, and maintenance of the Subtropical
- 2 Horticulture Research Station.

#### 3 SEC. 5. MISCELLANEOUS PROVISIONS.

- 4 (a) Security Fencing.—On or before closing for
- 5 the conveyance of the Property under this Act, the County
- 6 shall, at its cost, contract for the construction of a security
- 7 fence located on the boundary between the Property and
- 8 the adjacent land administered by the Secretary. The
- 9 fence shall be of materials and standards approved in ad-
- 10 vance by the Secretary. The Secretary may approve tem-
- 11 porary security structures for use during construction
- 12 phases.
- 13 (b) Other Terms.—The Secretary and the County
- 14 may otherwise effect the purpose of this Act on such addi-
- 15 tional terms as are mutually acceptable and which are not
- 16 inconsistent with the provisions of this Act.
