## A BILL

To direct the Secretary of Veterans Affairs to carry out demonstration projects related to providing care for veterans in rural areas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. DEMONSTRATION PROJECTS ON ALTER-
- 4 NATIVES FOR EXPANDING CARE FOR VET-
- 5 ERANS IN RURAL AREAS.
- 6 (a) IN GENERAL.—The Secretary of Veterans Af-
- 7 fairs, through the Director of the Office of Rural Health,
- 8 shall carry out demonstration projects to examine the fea-
- 9 sibility and advisability of alternatives for expanding care
- 10 for veterans in rural areas, including the following:

- 1 (1) Establishing a partnership between the De2 partment of Veterans Affairs and the Centers for
  3 Medicare and Medicaid Services of the Department
  4 of Health and Human Services to coordinate care
  5 for veterans in rural areas at critical access hospitals
  6 (as designated or certified under section 1820 of the
  7 Social Security Act (42 U.S.C. 1395i-4)).
  - (2) Establishing a partnership between the Department of Veterans Affairs and the Department of Health and Human Services to coordinate care for veterans in rural areas at community health centers.
- 12 (3) Expanding coordination between the De-13 partment of Veterans Affairs and the Indian Health 14 Service to expand care for Indian veterans.
- 15 (b) Geographic Distribution.—The Secretary of
  16 Veterans Affairs shall ensure that the demonstration
  17 projects carried out under subsection (a) are located at
  18 facilities that are geographically distributed throughout
  19 the United States.
- 20 (c) Report.—Not later than two years after the date 21 of the enactment of this Act, the Secretary of Veterans 22 Affairs shall submit a report on the results of the dem-23 onstration projects conducted under subsection (a) to—
- 24 (1) the Committee on Veterans' Affairs and the 25 Committee on Appropriations of the Senate; and

  (d) Authorization of Appropriations.—There
  are authorized to be appropriated \$350,000,000 for each
  fiscal years 2009 through 2011 to carry out this section.
