A BILL

To amend title 28, United States Code, to provide for a 6-month period for Federal judges to opt into the Judicial Survivors' Annuities System and begin contributing toward an annuity for their spouse and dependent children upon their death, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Judicial Survivors Pro-
- 5 tection Act of 2009".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:

1	(1) DIRECTOR.—The term "Director" means
2	the Director of the Administrative Office of the
3	United States Courts.
4	(2) Judicial official.—The term "judicial
5	official" means an individual who is a judicial offi-
6	cial, as defined in section 376(a) of title 28, United
7	States Code, on the date of enactment of this Act
8	(3) Judicial survivors' annuities fund.—
9	The term "Judicial Survivors' Annuities Fund'
10	means the fund established under section 3 of the
11	Judicial Survivors' Annuities Reform Act (28 U.S.C
12	376 note; Public Law 94–554; 90 Stat. 2611).
13	(4) Judicial survivors' annuities sys-
14	TEM.—The term "Judicial Survivors' Annuities Sys-
15	tem" means the program established under section
16	376 of title 28, United States Code.
17	(5) Open enrollment period.—The term
18	"open enrollment period" means the 6-month period
19	beginning on the 30th day after the date of enact-
20	ment of this Act.
21	SEC. 3. PERSONS NOT CURRENTLY PARTICIPATING IN THE
22	JUDICIAL SURVIVORS' ANNUITIES SYSTEM.
23	(a) Election of Judicial Survivors' Annuities

24 System Coverage.—Any judicial official may elect to

- 1 participate in the Judicial Survivors' Annuities System
- 2 during the open enrollment period.
- 3 (b) Manner of Making Elections.—An election
- 4 under this section is valid only if it is made in writing,
- 5 is signed by the person making the election, and is re-
- 6 ceived by the Director before the end of the open enroll-
- 7 ment period.
- 8 (c) Effective Date for Elections.—An election
- 9 under this section shall be effective as of the first day of
- 10 the first calendar month following the month in which the
- 11 election is received by the Director under subsection (b).
- 12 SEC. 4. JUDICIAL OFFICERS' CONTRIBUTIONS FOR OPEN
- 13 ENROLLMENT ELECTION.
- 14 (a) Contribution Rate.—Any judicial official who
- 15 files a written election under section 3(b), during the open
- 16 enrollment period, of his or her intention to participate
- 17 in the Judicial Survivors' Annuities System shall be
- 18 deemed thereby to consent and agree to having deducted
- 19 from his or her salary a sum equal to 2.75 percent of that
- 20 salary and a sum equal to 3.5 percent of his or her retire-
- 21 ment salary, except that the deduction from any retire-
- 22 ment salary—
- 23 (1) of a justice or judge of the United States
- retired from regular active service under section
- 25 371(b) or 372(a) of title 28, United States Code,

- 1 (2) of a judge of the United States Court of
- 2 Federal Claims retired under section 178 of title 28,
- 3 United States Code, or
- 4 (3) of a judicial official on recall under section
- 5 155(b), 373(c)(4), 375, or 636(h) of title 28, United
- 6 States Code,
- 7 shall be an amount equal to 2.75 percent of retirement
- 8 salary.
- 9 (b) Contributions To Be Credited to Judicial
- 10 Survivors' Annuities Fund.—Contributions made
- 11 under subsection (a) shall be credited to the Judicial Sur-
- 12 vivors' Annuities Fund.
- 13 SEC. 5. DEPOSIT FOR PRIOR CREDITABLE SERVICE.
- 14 (a) Lump Sum Deposit.—Any judicial official who
- 15 files a written election under section 3(b), during the open
- 16 enrollment period, of his or her intention to participate
- 17 in the Judicial Survivors' Annuities System may make a
- 18 deposit equaling 2.75 percent of salary, plus 3 percent in-
- 19 terest, compounded annually, for the last 18 months of
- 20 creditable civilian service, as computed in accordance with
- 21 section 376(k) of title 28, United States Code, in order
- 22 to receive the credit for prior judicial service required for
- 23 the payment of a survivor's annuity (under section 376
- 24 of such title) beginning on the date of death of the judicial

- 1 official. Any such deposit shall be made on or before the
- 2 last day of the open enrollment period.
- 3 (b) Deposits To Be Credited to Judicial Sur-
- 4 VIVORS' ANNUITIES FUND.—Deposits made under sub-
- 5 section (a) shall be credited to the Judicial Survivors' An-
- 6 nuities Fund.

7 SEC. 6. VOLUNTARY CONTRIBUTIONS TO ENLARGE SUR-

- 8 VIVORS' ANNUITY.
- 9 Section 376 of title 28, United States Code, is
- 10 amended by adding at the end the following:
- 11 "(y) Purchase of Additional Coverage.—
- 12 "(1) For those already enrolled.—Any
- judicial official who is enrolled in the Judicial Sur-
- vivors' Annuities System, other than a judicial offi-
- cial to whom paragraph (2) applies, may purchase,
- in 3-month increments, for each year of creditable
- service completed, up to an additional year of cred-
- itable service, under the terms set forth in sub-
- section (b) of this section. This paragraph applies to
- a judicial official without regard to any contributions
- 21 made by such official under subsection (d).
- 22 "(2) For those enrolled under judicial
- 23 SURVIVORS PROTECTION ACT OF 2009.—Any judicial
- official who elects to enroll in the Judicial Survivors'
- 25 Annuities System during the open enrollment period

1	authorized under the Judicial Survivors Protection
2	Act of 2009 may purchase, in 3-month increments,
3	for each year of creditable service completed, up to
4	an additional year of creditable service, under the
5	terms set forth in section 4(a) of that Act.
6	"(3) Definitions.—In this subsection:
7	"(A) Judicial survivors' annuities
8	System.—The term 'Judicial Survivors' Annu-
9	ities System' means the annuity program estab-
10	lished under this section.
11	"(B) Creditable Service.—The term
12	'creditable service' means the service rendered
13	by a judicial official in any position described in
14	paragraph (1) of subsection (a).".
15	SEC. 7. EFFECTIVE DATE.
16	This Act and the amendment made by this Act shall
