## AN ACT

To restore sums to the Highway Trust Fund and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

1 **SECTION 1. FUNDING OF THE HIGHWAY TRUST FUND.**

2 Subsection (f) of section 9503 of the Internal Rev-  
3 enue Code of 1986 (relating to determination of trust fund  
4 balances after September 30, 1998) is amended—

5 (1) by striking paragraph (2); and

6 (2) by adding at the end the following new  
7 paragraph:

8 “(2) INCREASE IN FUND BALANCE.—Out of  
9 money in the Treasury not otherwise appropriated,  
10 there is hereby appropriated (without fiscal year lim-  
11 itation) to the Highway Trust Fund  
12 \$7,000,000,000.”.

13 **SEC. 2. ADVANCES TO THE UNEMPLOYMENT TRUST FUND**  
14 **AND OTHER FUNDS.**

15 The item relating to “Department of Labor—Em-  
16 ployment and Training Administration—Advances to the  
17 Unemployment Trust Fund and Other Funds” in title I  
18 of division F of the Omnibus Appropriations Act, 2009  
19 (Public Law 111–8; 123 Stat. 754) is amended by striking  
20 “to remain available through September 30, 2010” and  
21 all that follows (before the heading for the following item)  
22 and inserting “such sums as may be necessary”.

23 **SEC. 3. FHA MORTGAGE INSURANCE COMMITMENT AU-**  
24 **THORITY.**

25 The item relating to “Federal Housing Administra-  
26 tion—Mutual Mortgage Insurance Program Account” in

1 title II of division I of the Omnibus Appropriations Act,  
2 2009 (Public Law 111–8; 123 Stat. 966) is amended by  
3 striking “\$315,000,000,000” and inserting  
4 “\$400,000,000,000”.

5 **SEC. 4. GNMA MORTGAGE-BACKED SECURITIES GUAR-**  
6 **ANTEE COMMITMENT AUTHORITY.**

7 The item relating to “Government National Mortgage  
8 Association—Guarantees of Mortgage-Backed Securities  
9 Loan Guarantee Program Account” in title II of division  
10 I of the Omnibus Appropriations Act, 2009 (Public Law  
11 111–8; 123 Stat. 967) is amended by striking  
12 “\$300,000,000,000” and inserting “\$400,000,000,000”.
