1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

**3** SECTION 1. FUNDING OF THE HIGHWAY TRUST FUND.

4 Subsection (f) of section 9503 of the Internal Rev5 enue Code of 1986 (relating to determination of trust fund
6 balances after September 30, 1998) is amended—

7 (1) by striking paragraph (2), and

8 (2) by adding at the end the following new9 paragraph:

10 "(2) INCREASE IN FUND BALANCE.—Out of 11 money in the Treasury not otherwise appropriated, there is hereby appropriated (without fiscal year lim itation) to the Highway Trust Fund
 \$5,000,000,000.".

## 4 SEC. 2. ADVANCES TO THE UNEMPLOYMENT TRUST FUND 5 AND OTHER FUNDS.

6 The item relating to "Department of Labor—Em-7 ployment and Training Administration—Advances to the 8 Unemployment Trust Fund and Other Funds" in title I 9 of division F of the Omnibus Appropriations Act, 2009 10 (Public Law 111–8; 123 Stat. 754) is amended by striking 11 "to remain available through September 30, 2010" and 12 all that follows (before the heading for the following item) and inserting "such sums as may be necessary". 13

16 The item relating to "Federal Housing Administra-17 tion—Mutual Mortgage Insurance Program Account" in 18 title II of division I of the Omnibus Appropriations Act, 19 2009 (Public Law 111–8; 123 Stat. 966) is amended by 20 striking "\$315,000,000,000" and inserting 21 "\$400,000,000,000".
