 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Veterans Education
 - 5 Enhancement and Fairness Act of 2009".

1	SEC. 2. MONTHLY HOUSING STIPEND UNDER POST-9/11
2	EDUCATIONAL ASSISTANCE PROGRAM FOR
3	INDIVIDUALS PURSUING PROGRAMS OF EDU-
4	CATION OFFERED THROUGH DISTANCE
5	LEARNING.
6	(a) In General.—Section 3313(c)(1)(B)(i) of title
7	38, United States Code, is amended—
8	(1) by striking the following: "(other than, in
9	the case of assistance under this section only, a pro-
10	gram of education offered through distance learn-
11	ing)"; and
12	(2) by adding at the end the following: ", ex-
13	cept that in the case of an individual pursuing a pro-
14	gram of education offered through distance learning,
15	the amount of the monthly housing stipend under
16	this clause shall be the amount equal to the monthly
17	amount of the basic allowance for housing payable
18	under section 403 of title 37 for a member with de-
19	pendents in pay grade E-5 residing in the military
20	housing area that encompasses all or the majority
21	portion of the ZIP code area in which the individual
22	resides.".
23	(b) Effective Date.—The amendments made by
24	subsection (a) shall apply with respect to a month begin-
25	ning on or after the date that is 180 days after the date

26 of the enactment of this Act.

1	SEC. 3. INCLUSION OF CERTAIN ACTIVE DUTY SERVICE IN
2	THE RESERVE COMPONENTS AS QUALIFYING
3	SERVICE FOR PURPOSES OF POST-9/11 EDU-
4	CATIONAL ASSISTANCE PROGRAM.
5	(a) In General.—Section 3301(1) of title 38,
6	United States Code, is amended by adding at the end the
7	following new subparagraph:
8	"(C) In the case of members of the Army
9	National Guard or Air National Guard of any
10	State, full-time duty under section 502(f) of
11	title 32, including duty in support of any home-
12	land security operation, natural disaster related
13	operation, counter-narcotic operation, or border
14	security operation and duty in the Active Guard
15	Reserve.".
16	(b) Effective Date.—The amendment made by
17	subsection (a) shall take effect on the date that is 180
18	days after the date of the enactment of this Act.
