A BILL

To amend title 38, United States Code, to deem certain service in the Reserve components as active service for purposes of laws administered by the Secretary of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CERTAIN SERVICE PERFORMED IN THE RE-**
4 **SERVE COMPONENTS DEEMED ACTIVE SERV-**
5 **ICE.**

6 Section 106 of title 38, United States Code, is
7 amended by adding at the end the following new sub-
8 section:

9 “(g) Any person who has not otherwise performed
10 qualifying active duty service shall be deemed to have been
11 on active duty for purposes of all laws administered by
12 the Secretary if the person is entitled under chapter 1223
13 of title 10 to retired pay for nonregular service or, but
14 for age, would be entitled under such chapter to retired
15 pay for nonregular service.”

16 **SECTION 1. PROVISION OF STATUS UNDER LAW BY HON-**
17 **ORING CERTAIN MEMBERS OF THE RESERVE**
18 **COMPONENTS AS VETERANS.**

19 (a) *IN GENERAL.*—Chapter 1 of title 38, United States
20 Code, is amended by inserting after section 107 the fol-
21 lowing new section:

1 **“§ 107A. Honoring as veterans certain persons who**
2 **performed service in the reserve compo-**
3 **nents**

4 *“Any person who is entitled under chapter 1223 of title*
5 *10 to retired pay for nonregular service or, but for age,*
6 *would be entitled under such chapter to retired pay for non-*
7 *regular service shall be honored as a veteran but shall not*
8 *be entitled to any benefit by reason of this section.”.*

9 (b) *CLERICAL AMENDMENT.—The table of sections at*
10 *the beginning of such chapter is amended by inserting after*
11 *the item relating to section 107 the following new item:*

“107A. Honoring as veterans certain persons who performed service in the reserve components.”.

Amend the title so as to read: “A bill to amend title 38, United States Code, to recognize the service in the reserve components of certain persons by honoring them with status as veterans under law.”.
