A BILL

To extend certain expiring provisions providing enhanced protections for servicemembers relating to mortgages and mortgage foreclosure.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Helping Heroes Keep
5 Their Homes Act of 2009”.

6 **SEC. 2. EXTENSION OF ENHANCED PROTECTIONS FOR**
7 **SERVICEMEMBERS RELATING TO MORT-**
8 **GAGES AND MORTGAGE FORECLOSURE**
9 **UNDER SERVICEMEMBERS CIVIL RELIEF**
10 **ACT.**

11 Section 2203(e)(2) of the Housing and Economic Re-
12 cover Act of 2008 (Public Law 110–289) is amended—

13 (1) by striking “December 31, 2010” and in-
14 serting “December 31, 2015”; and

15 (2) by striking “January 1, 2011” and insert-
16 ing “January 1, 2016”.

17 **SECTION 1. SHORT TITLE.**

18 *This Act may be cited as the “Veterans Employment*
19 *and Home Preservation Act of 2010”.*

1 **SEC. 2. EXTENSION OF ENHANCED PROTECTIONS FOR**
2 **SERVICEMEMBERS RELATING TO MORTGAGES**
3 **AND MORTGAGE FORECLOSURE UNDER**
4 **SERVICEMEMBERS CIVIL RELIEF ACT.**

5 (a) *EXTENSION.*—Paragraph (2) of section 2203(c) of
6 the Housing and Economic Recovery Act of 2008 (Public
7 Law 110-289) is amended—

8 (1) by striking “December 31, 2010” and insert-
9 ing “December 31, 2015”; and

10 (2) by striking “January 1, 2011” and inserting
11 “January 1, 2016”.

12 (b) *PROTECTION FOR SURVIVING SPOUSE.*—

13 (1) *IN GENERAL.*—Section 303 of the
14 Servicemembers Civil Relief Act (50 U.S.C. App. 533)
15 is amended by adding at the end the following new
16 subsection:

17 “(e) *PROTECTION FOR SURVIVING SPOUSE.*—With re-
18 spect to a servicemember who dies while in military service
19 and whose death is service-connected, this section shall
20 apply to the surviving spouse of the servicemember if such
21 spouse is the successor in interest to property covered under
22 subsection (a).”.

23 (2) *EFFECTIVE DATE.*—Subsection (e) of section
24 303 of such Act, as added by paragraph (1), shall
25 apply to a surviving spouse of a servicemember whose

1 *death is on or after the date of the enactment of this*
2 *Act.*

3 **SEC. 3. TEMPORARY REDUCTION OF REQUIRED AMOUNT OF**
4 **WAGES FOR ON-THE-JOB TRAINING PRO-**
5 **GRAMS.**

6 *(a) IN GENERAL.—*

7 *(1) REDUCING REQUIREMENT.—Clause (ii) of*
8 *section 3677(b)(1)(A) of title 38, United States Code,*
9 *is amended by striking “85 per centum” and insert-*
10 *ing “60 percent”.*

11 *(2) EFFECTIVE DATE.—The amendment made by*
12 *paragraph (1) shall take effect on October 1, 2010,*
13 *and shall apply to a veteran who enrolls in a pro-*
14 *gram of training on the job approved under section*
15 *3677 of such title on or after such date.*

16 *(b) SUNSET.—*

17 *(1) REVERSION.—Effective October 1, 2013,*
18 *clause (ii) of section 3677(b)(1)(A) of title 38, United*
19 *States Code, as amended by subsection (a) of this sec-*
20 *tion, is amended by striking “60 percent” and insert-*
21 *ing “85 percent”.*

22 *(2) APPLICATION.—The amendment made by*
23 *paragraph (1) shall apply to a veteran who enrolls in*
24 *a program of training on the job approved under sec-*
25 *tion 3677 of such title on or after October 1, 2013.*

1 (c) *GAO REPORT.—Not later than October 1, 2013,*
2 *the Comptroller General of the United States shall submit*
3 *to the Committee on Veterans’ Affairs of the House of Rep-*
4 *resentatives and the Committee on Veterans’ Affairs of the*
5 *Senate a report on the effects of the amendment made by*
6 *subsection (a)(1) that reduces the wage increase requirement*
7 *under section 3677(b)(1)(A)(ii) of title 38, United States*
8 *Code.*

Amend the title so as to read: “A bill to extend certain expiring provisions providing enhanced protections for servicemembers relating to mortgages and mortgage foreclosure, and for other purposes.”.
