- 4 This Act may be cited as the "Rural Veterans Reim-
- 5 bursement Act".

6 SEC. 2. INCREASED PAYMENTS FOR TRAVEL.

- 7 (a) IN GENERAL.—Section 111 of title 38, United

 and subsistence"; and

"(i)(1) Notwithstanding subsection (g)(2)(A), in de-6 7 termining the amount of allowances or reimbursement to 8 be paid under this section to a veteran described in para-9 graph (2) for lodging and subsistence expenses, the Sec-10 retary shall use the amount that is equal to the amount that would be payable or reimbursable under subchapter 11 12 I of chapter 57 of title 5, United States Code, if such vet-13 eran were an employee of the Department of Veterans Affairs traveling on official business away from the employ-14 15 ee's home.
