A BILL

To authorize the Secretary of the Interior to conduct a special resource study to determine the suitability and feasibility of designating the Colonel Charles Young Home in Xenia, Ohio as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Colonel Charles Young*
5 *Home Study Act”.*

6 **SEC. 2. SPECIAL RESOURCE STUDY.**

7 *(a) STUDY.—The Secretary of the Interior (referred to*
8 *in this Act as the “Secretary”), in consultation with the*
9 *Secretary of the Army, shall conduct a special resource*
10 *study of the Colonel Charles Young Home, a National His-*
11 *toric Landmark in Xenia, Ohio (referred to in this Act as*
12 *the “Home”).*

13 *(b) CONTENTS.—In conducting the study under sub-*
14 *section (a), the Secretary shall—*

15 *(1) evaluate any architectural and archeological*
16 *resources of the Home;*

17 *(2) determine the suitability and feasibility of*
18 *designating the Home as a unit of the National Park*
19 *System;*

20 *(3) consider other alternatives for preservation,*
21 *protection, and interpretation of the Home by Fed-*
22 *eral, State, or local governmental entities or private*
23 *and nonprofit organizations, including the use of*
24 *shared management agreements with the Dayton*
25 *Aviation Heritage National Historical Park or spe-*

1 *cific units of that Park, such as the Paul Laurence*
2 *Dunbar Home;*

3 (4) *consult with the Ohio Historical Society,*
4 *Central State University, Wilberforce University, and*
5 *other interested Federal, State, or local governmental*
6 *entities, private and nonprofit organizations, or indi-*
7 *viduals; and*

8 (5) *identify cost estimates for any Federal acqui-*
9 *sition, development, interpretation, operation, and*
10 *maintenance associated with the alternatives consid-*
11 *ered under the study.*

12 (c) *APPLICABLE LAW.*—*The study required under sub-*
13 *section (a) shall be conducted in accordance with section*
14 *8 of Public Law 91–383 (16 U.S.C. 1a–5).*

15 (d) *REPORT.*—*Not later than 3 years after the date*
16 *on which funds are first made available for the study under*
17 *subsection (a), the Secretary shall submit to the Committee*
18 *on Natural Resources of the House of Representatives and*
19 *the Committee on Energy and Natural Resources of the Sen-*
20 *ate a report that contains—*

21 (1) *the results of the study under subsection (a);*
22 *and*

23 (2) *any conclusions and recommendations of the*
24 *Secretary.*
