## AN ACT

To protect the integrity of the constitutionally mandated United States census and prohibit deceptive mail practices that attempt to exploit the decennial census.

- 8 OR SERVICE.—Section 3001(h) of title 39, United States
- 9 Code, is amended—
- 10 (1) by inserting, in the matter preceding para-
- graph (1), "; or which bears the term 'census' on the
- 12 envelope or outside cover or wrapper" after "such
- matter by the Federal Government";
- 14 (2) in paragraph (2), by redesignating subpara-
- graphs (A), (B), and (C) as clauses (i), (ii), and
