A BILL

To amend the Office of National Drug Control Policy Reauthorization Act of 2006 to require a northern border counternarcotics strategy, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Northern Border
- 5 Counternarcotics Strategy Act of 2010".

1	SEC. 2. NORTHERN BORDER COUNTERNARCOTICS STRAT-
2	EGY.
3	The Office of National Drug Control Policy Reau-
4	thorization Act of 2006 (Public Law 109–469) is amended
5	by inserting after section 1110 the following new section:
6	"SEC. 1110A. REQUIREMENT FOR NORTHERN BORDER
7	COUNTERNARCOTICS STRATEGY.
8	"(a) In General.—Not later than 120 days after
9	the date of the enactment of this section and every two
10	years thereafter, the Director of National Drug Control
11	Policy, in coordination with the Secretary of Homeland
12	Security, shall submit to Congress a Northern Border
13	Counternarcotics Strategy.
14	"(b) Purposes.—The Northern Border Counter-
15	narcotics Strategy shall—
16	"(1) set forth the Government's strategy for
17	preventing the illegal trafficking of drugs across the
18	international border between the United States and
19	Canada, including through ports of entry and be-
20	tween ports of entry on that border;
21	"(2) state the specific roles and responsibilities
22	of the relevant National Drug Control Program
23	agencies (as defined in section 702 of the Office of
24	National Drug Control Policy Reauthorization Act of
25	1998 (21 U.S.C. 1701)) and the Office of Counter-

1	narcotics Enforcement of the Department of Home-
2	land Security for implementing that strategy; and
3	"(3) identify the specific resources required to
4	enable the relevant National Drug Control Program
5	agencies and the Office of Counternarcotics Enforce-
6	ment of the Department of Homeland Security to
7	implement that strategy.
8	"(c) Specific Content Related to Cross-Bor-
9	DER INDIAN RESERVATIONS.—The Northern Border
10	Counternarcotics Strategy shall include—
11	"(1) a strategy to end the illegal trafficking of
12	drugs through Indian reservations that straddle the
13	international border between the United States and
14	Canada; and
15	"(2) recommendations for additional assistance
16	to tribal law enforcement agencies with respect to
17	such strategy.
18	"(d) Consultation With Other Agencies.—The
19	Director shall issue the Northern Border Counternarcotics
20	Strategy in consultation with the heads of the relevant Na-
21	tional Drug Control Program agencies.

- 22 "(e) Limitation.—The Northern Border Counter-
- 23 narcotics Strategy shall not change existing agency au-
- 24 thorities or the laws governing interagency relationships,

- 1 but may include recommendations about changes to such
- 2 authorities or laws.
- 3 "(f) Report to Congress.—The Director shall pro-
- 4 vide a copy of the Northern Border Counternarcotics
- 5 Strategy to the appropriate congressional committees (as
- 6 defined in section 702 of the Office of National Drug Con-
- 7 trol Policy Reauthorization Act of 1998 (21 U.S.C.
- 8 1701)), and to the Committee on Armed Services and the
- 9 Committee on Homeland Security of the House of Rep-
- 10 resentatives, and the Committee on Homeland Security
- 11 and Governmental Affairs and the Committee on Armed
- 12 Services of the Senate.
- 13 "(g) Treatment of Classified or Law Enforce-
- 14 MENT SENSITIVE INFORMATION.—Any content of the
- 15 Northern Border Counternarcotics Strategy that involves
- 16 information classified under criteria established by an Ex-
- 17 ecutive order, or whose public disclosure, as determined
- 18 by the Director or the head of any relevant National Drug
- 19 Control Program agency, would be detrimental to the law
- 20 enforcement or national security activities of any Federal,
- 21 State, local, or tribal agency, shall be presented to Con-
- 22 gress separately from the rest of the Strategy.".
