- To provide for the International Organizations Immunities Act to be extended to the Office of the High Representative in Bosnia and Herzegovina and the International Civilian Office in Kosovo.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Extending Immunities
- 3 to the Office of the High Representative in Bosnia and
- 4 Herzegovina and the International Civilian Office in
- 5 Kosovo Act of 2010".
- 6 SEC. 2. AUTHORITY TO EXTEND THE PROVISIONS OF THE
- 7 INTERNATIONAL ORGANIZATIONS IMMUNI-
- 8 TIES ACT TO THE OFFICE OF THE HIGH REP-
- 9 RESENTATIVE IN BOSNIA AND HERZEGOVINA
- 10 AND THE INTERNATIONAL CIVILIAN OFFICE
- 11 IN KOSOVO.
- The International Organizations Immunities Act (22)
- 13 U.S.C. 288 et seq.) is amended by adding at the end the
- 14 following new section:
- 15 "Sec. 17. The provisions of this title may be ex-
- 16 tended to the Office of the High Representative in Bosnia
- 17 and Herzegovina (and to its officers and employees) or
- 18 the International Civilian Office in Kosovo (and to its offi-
- 19 cers and employees) in the same manner, to the same ex-
- 20 tent, and subject to the same conditions, as such provi-
- 21 sions may be extended to a public international organiza-
- 22 tion in which the United States participates pursuant to
- 23 any treaty or under the authority of any Act of Congress
- 24 authorizing such participation or making an appropriation
- 25 for such participation. Any such extension may provide for
- 26 the provisions of this title to continue to extend to the

- 1 Office of the High Representative in Bosnia and
- 2 Herzegovina (and to its officers and employees) or the
- 3 International Civilian Office in Kosovo (and to its officers
- 4 and employees) after that Office has been dissolved.".

5 SEC. 3. BUDGET COMPLIANCE.

- 6 The budgetary effects of this Act, for the purpose of
- 7 complying with the Statutory Pay-As-You-Go Act of 2010,
- 8 shall be determined by reference to the latest statement
- 9 titled "Budgetary Effects of PAYGO Legislation" for this
- 10 Act, submitted for printing in the Congressional Record
- 11 by the Chairman of the House Budget Committee, pro-
- 12 vided that such statement has been submitted prior to the
- 13 vote on passage.
