A BILL

To expand the boundaries of the Cibola National Forest
in the State of New Mexico.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CIBOLA NATIONAL FOREST BOUNDARY EXPAN-**
4 **SION.**

5 *(a) BOUNDARY EXPANSION.—The boundaries of Cibola*
6 *National Forest, located in the State of New Mexico, are*
7 *hereby modified to include the land depicted for such inclu-*
8 *sion on the Bureau of Land Management map entitled*
9 *“Manzano Wilderness Study Area”, dated August 31, 2009.*

10 *(b) AVAILABILITY AND CORRECTION OF MAP.—The*
11 *map referred to in subsection (a) shall be on file and avail-*
12 *able for public inspection in the appropriate offices of the*
13 *Forest Service. The Chief of the Forest Service is authorized*
14 *to make technical and clerical corrections to the map.*

15 *(c) TRANSFER OF JURISDICTION.—Administrative ju-*
16 *risdiction over any land under the jurisdiction of the Sec-*
17 *retary of the Interior that is depicted on the map referred*
18 *to in subsection (a) is hereby transferred to the Secretary*
19 *of Agriculture, and such lands shall be subject to the laws*
20 *and regulations pertaining to the National Forest System.*

21 *(d) MANZANO MOUNTAIN WILDERNESS ADDITION.—*

22 *(1) DESIGNATION.—The land depicted as the*
23 *Manzano Wilderness Study Area on the map referred*
24 *to in subsection (a)—*

25 *(A) is hereby designated as wilderness; and*

1 (B) is added to the Manzano Mountain Wil-
2 derness designated by section 2(f) of the Endan-
3 gered American Wilderness Act of 1978 (Public
4 Law 95–237; 92 Stat. 42; 16 U.S.C. 1132 note).

5 (2) ADMINISTRATION.—The lands designated as
6 wilderness in paragraph (1) shall be administered by
7 the Secretary of Agriculture in accordance with Wil-
8 derness Act (16 U.S.C. 1131 et seq.), except that any
9 reference in the Wilderness Act to the effective date
10 shall be considered to be a reference to the date of en-
11 actment of this Act.

12 (e) RELATION TO LAND AND WATER CONSERVATION
13 FUND ACT.—For purposes of section 7 of the Land and
14 Water Conservation Fund Act of 1965 (16 U.S.C. 460l–9),
15 the boundaries of the Cibola National Forest, as modified
16 by subsection (a), shall be considered to be boundaries of
17 the Cibola National Forest as of January 1, 1965.
