AN ACT

- To establish a program of research, recovery, and other activities to provide for the recovery of the southern sea otter.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Southern Sea Otter3 Recovery and Research Act".

4 SEC. 2. SOUTHERN SEA OTTER RECOVERY AND RESEARCH 5 PROGRAM.

6 (a) IN GENERAL.—The Secretary of the Interior, act-7 ing through the United States Fish and Wildlife Service 8 and the United States Geological Survey, shall carry out 9 a recovery and research program for southern sea otter 10 populations along the coast of California, informed by the 11 prioritized research recommendations of the Final Revised 12 Recovery Plan for the southern sea otter (Enhydra lutris 13 nereis) published by the United States Fish and Wildlife Service and dated February 24, 2003, the Research Plan 14 15 for California Sea Otter Recovery issued by the United 16 States Fish and Wildlife Service Southern Sea Otter Recovery Implementation Team and dated March 2, 2007, 17 18 and any other recovery, research, or conservation plan 19 adopted by the United States Fish and Wildlife Service 20after the date of enactment of this Act in accordance with 21 otherwise applicable law. The Recovery and Research Pro-22 gram shall include the following:

(1) Monitoring, analysis, and assessment of
southern sea otter population demographics, health,
causes of mortality, and life history parameters, including range-wide population surveys.

(2) Development and implementation of meas ures to reduce or eliminate potential factors limiting
 southern sea otter populations that are related to
 marine ecosystem health or human activities.

5 (b) REAPPOINTMENT OF RECOVERY IMPLEMENTA-6 TION TEAM.—Not later than one year after the date of 7 enactment of this Act, the Secretary shall appoint persons 8 to a southern sea otter recovery implementation team as 9 authorized under section 4(f)(2) of the Endangered Spe-10 cies Act of 1973 (16 U.S.C. 1533(f)(2)).

11 (c) SOUTHERN SEA OTTER RESEARCH AND RECOV-12 ERY GRANTS.—

(1) GRANT AUTHORITY.—The Secretary shall
establish a peer-reviewed, merit-based process to
award competitive grants for research regarding
southern sea otters and for projects assisting the recovery of southern sea otter populations.

(2) PEER REVIEW PANEL.—The Secretary shall
establish as necessary a peer review panel to provide
scientific advice and guidance to prioritize proposals
for grants under this subsection.

(3) RESEARCH GRANT SUBJECTS.—Research
funded with grants under this subsection shall be in
accordance with the research recommendations of

| 8 | SEC. 3. DEFINITIONS. |
| 9 | In this Act: |
| 10 | (1) Recovery and research program.—The |
| 11 | term "Recovery and Research Program" means the |
| 12 | recovery and research program under section 2(a). |
| 13 | (2) Secretary.—The term "Secretary" means |
| 14 | the Secretary of the Interior, acting through the |
| 15 | United States Fish and Wildlife Service and the |
| 16 | United States Geological Survey. |
| 17 | SEC. 4. AUTHORIZATION OF APPROPRIATIONS. |
| 18 | (a) IN GENERAL.—There is authorized to be appro- |
| 19 | priated to the Secretary to carry out this Act \$5,000,000 |
| 20 | for each of fiscal years 2010 through 2015 of which— |
| 21 | (1) no less than 30 percent shall be for research |
| 22 | grants under section $2(c)(3)$; and |
| 23 | (2) no less than 30 percent shall be for recovery |
| 24 | projects under section $2(c)(4)$. |

(b) ADMINISTRATIVE EXPENSES.—Of amounts avail able each fiscal year to carry out this Act, the Secretary
 may expend not more than 7 percent to pay the adminis trative expenses necessary to carry out this Act.

5 SEC. 5. TERMINATION.

6 This Act shall have no force or effect on and after
7 the date the Secretary (as that term is used in section
8 4(c)(2) of the Endangered Species Act of 1973 (16 U.S.C.
9 1533(c)(2)) publishes a determination that the southern
10 sea otter should be removed from the lists published under
11 section 4(c) of the Endangered Species Act of 1973 (16
12 U.S.C. 1533(c)).
