A BILL

To designate the facility of the Federal Aviation Administration located at Spokane International Airport in Spokane, Washington, as the “Ray Daves Air Traffic Control Tower”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RAY DAVES AIR TRAFFIC CONTROL TOWER.**

4 (a) DESIGNATION.—The facility of the Federal Avia-
5 tion Administration located at Spokane International Air-
6 port in Spokane, Washington, shall be known and des-
7 ignated as the “Ray Daves Air Traffic Control Tower”.

8 (b) REFERENCES.—Any reference in a law, map, reg-
9 ulation, document, paper, or other record of the United
10 States to the facility referred to in subsection (a) shall
11 be deemed to be a reference to the “Ray Daves Air Traffic
12 Control Tower”.

13 **SECTION 1. DESIGNATION.**

14 *The airport traffic control tower located at Spokane*
15 *International Airport in Spokane, Washington, and any*
16 *successor airport traffic control tower at that location, shall*
17 *be known and designated as the “Ray Daves Airport Traffic*
18 *Control Tower”.*

19 **SEC. 2. REFERENCES.**

20 *Any reference in a law, map, regulation, document,*
21 *paper, or other record of the United States to the airport*
22 *traffic control tower referred to in section 1 shall be deemed*
23 *to be a reference to the “Ray Daves Airport Traffic Control*
24 *Tower”.*

Amend the title so as to read: “A bill to designate the airport traffic control tower located at Spokane International Airport in Spokane, Washington, as the ‘Ray Daves Airport Traffic Control Tower’.”.
