## A BILL

To rescind amounts authorized for certain surface  
transportation programs.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Surface Transpor-  
5       tation Savings Act of 2010”.

6       **SEC. 2. SAFETY BELT PERFORMANCE GRANTS.**

7       (a) IN GENERAL.—Subject to subsection (b), of the  
8       amounts authorized for fiscal year 2010 by section  
9       2001(a)(4) of SAFETEA-LU (119 Stat. 1519) to carry  
10      out section 406 of title 23, United States Code,  
11      \$80,994,029 is rescinded.

1 (b) LIMITATION.—The amount rescinded pursuant to  
2 subsection (a) shall be decreased as necessary to ensure  
3 that not less than \$28,505,971 is available for fiscal year  
4 2010 to carry out section 406 of title 23, United States  
5 Code.

6 **SEC. 3. ADMINISTRATIVE EXPENSES.**

7 Of the amounts authorized for fiscal year 2010 by  
8 section 2001(a)(11) of SAFETEA–LU (119 Stat. 1520),  
9 \$6,547,000 is rescinded.

10 **SEC. 4. NATIONAL DRIVER REGISTER.**

11 Of the amounts authorized for fiscal year 2010 by  
12 section 2001(a)(7) of SAFETEA–LU (119 Stat. 1520)  
13 for the National Driver Register authorized under chapter  
14 303 of title 49, United States Code, \$78,000 is rescinded.

15 **SEC. 5. NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRA-**  
16 **TION OPERATIONS AND RESEARCH.**

17 Of the amounts authorized for fiscal year 2010 by  
18 section 2001(a)(2) of SAFETEA–LU (119 Stat. 1519) to  
19 carry out section 403 of title 23, United States Code,  
20 \$1,829,000 is rescinded.

21 **SEC. 6. TRANSIT FORMULA AND BUS GRANTS.**

22 Of the amounts authorized for fiscal year 2010 by  
23 section 5338(b)(1) of title 49, United States Code, to  
24 carry out sections 5305, 5307, 5308, 5309, 5310, 5311,  
25 5316, 5317, 5320, 5335, 5339, and 5340 of title 49,

1 United States Code, and section 3038 of the Federal  
2 Transit Act of 1998 (112 Stat. 392), \$17,394,000 is re-  
3 scinded.
