# **A BILL**

To improve certain administrative operations of the Library  
of Congress, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMITTING USE OF PROCEEDS FROM DIS-**  
4 **POSITION OF SURPLUS OR OBSOLETE PER-**  
5 **SONAL PROPERTY.**

6 (a) DISPOSITION OF PROPERTY.—Within the limits  
7 of available appropriations, the Librarian of Congress may  
8 dispose of surplus or obsolete personal property of the Li-  
9 brary of Congress by interagency transfer, donation, sale,  
10 trade-in, or other appropriate method.

11 (b) USE OF PROCEEDS.—Any amounts received by  
12 the Librarian of Congress from the disposition of property  
13 under subsection (a) shall be credited to the funds avail-  
14 able for the operations of the Library of Congress, and  
15 shall be available to acquire the same or similar property  
16 during the fiscal year in which the amounts are received  
17 and the following fiscal year.

18 (c) EFFECTIVE DATE.—This section shall apply with  
19 respect to fiscal year 2011 and each succeeding fiscal year.

20 **SEC. 2. AVAILABILITY OF FUNDS FOR STUDENT LOAN RE-**  
21 **PAYMENT PROGRAM FOR EMPLOYEES.**

22 (a) AVAILABILITY OF FUNDS WITHOUT REGARD TO  
23 SOURCE OF EMPLOYEE SALARY.—Amounts appropriated  
24 or otherwise made available to the Librarian of Congress  
25 for a fiscal year for salaries and expenses of employees

1 of the Library of Congress may be used by the Librarian  
2 to make payments under the student loan repayment pro-  
3 gram under section 5379 of title 5, United States Code,  
4 on behalf of an employee of the Library without regard  
5 to the source of the funds used to pay the employee's sal-  
6 ary.

7 (b) EFFECTIVE DATE.—This section shall apply with  
8 respect to fiscal year 2011 and each succeeding fiscal year.

9 **SEC. 3. USE OF UNOBLIGATED APPROPRIATIONS TO MAKE**  
10 **CONTRIBUTIONS TO WORKERS COMPENSA-**  
11 **TION FUND.**

12 (a) USE OF FUNDS.—Unobligated balances of ex-  
13 pired appropriations made to the Library of Congress for  
14 fiscal years beginning with fiscal year 2011 shall be avail-  
15 able to the Librarian of Congress to make the deposit to  
16 the credit of the Employees' Compensation Fund required  
17 by subsection 8147(b) of title 5, United States Code.

18 (b) EFFECTIVE DATE.—This section shall apply with  
19 respect to fiscal year 2011 and each succeeding fiscal year.
