AN ACT

To rescind earmarks for certain surface transportation projects.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Surface Transpor-
- 3 tation Earmark Rescission, Savings, and Accountability
- 4 Act".

5 SEC. 2. RESCISSION OF ALLOCATED PROJECT FUNDS.

- 6 (a) ISTEA AND STURAA.—The unobligated bal-
- 7 ances available on December 31, 2010, under sections
- 8 1103(b), 1104(b), 1105(f), 1106(a), 1106(b), 1107(b),
- 9 and 1108(b) of the Intermodal Surface Transportation Ef-
- 10 ficiency Act of 1991 (Public Law 102–240) and sub-
- 11 sections (c) and (d) of section 149 of the Surface Trans-
- 12 portation and Uniform Relocation Assistance Act of 1987
- 13 (Public Law 100–17) are rescinded.
- 14 (b) TEA 21.—The unobligated balance available on
- 15 September 30, 2011, under section 1602 of the Transpor-
- 16 tation Equity Act for the 21st Century (Public Law 105–
- 17 178) for each project for which less than 10 percent of
- 18 the amount authorized for such project under such section
- 19 has been obligated is rescinded.
- 20 SEC. 3. REPEAL OF APPALACHIAN DEVELOPMENT HIGH-
- 21 WAY SYSTEM CORRIDOR DESIGNATION.
- Section 1117(d) of the Transportation Equity Act for
- 23 the 21st Century (112 Stat. 161) is repealed and the des-
- 24 ignation made by that section shall no longer be effective.

1 SEC. 4. RESCISSION OF UNDESIGNATED HIGH PRIORITY

- 2 **PROJECT FUNDS.**
- 3 Of the amounts authorized for fiscal years 2005
- 4 through 2009 in section 1101(a)(16) of the Safe, Account-
- 5 able, Flexible, Efficient Transportation Equity Act: A
- 6 Legacy for Users (Public Law 109–59) to carry out the
- 7 high priority projects program under section 117 of title
- 8 23, United States Code, that are not allocated for projects
- 9 described in section 1702 of such Act, \$8,190,355 are re-
- 10 scinded.

11 **SEC. 5. REPORT.**

- Not later than October 31, 2011, and not later than
- 13 October 31 of each year thereafter, the Secretary shall
- 14 submit to the Committee on Transportation and Infra-
- 15 structure of the House of Representatives and the Com-
- 16 mittee on Environment and Public Works of the Senate
- 17 a report identifying each project authorized under section
- 18 1602 of the Transportation Equity Act for the 21st Cen-
- 19 tury (Public Law 105–178), sections 1301, 1302, 1702,
- 20 and 1934 of the Safe, Accountable, Flexible, Efficient
- 21 Transportation Equity Act: A Legacy for Users (Public
- 22 Law 109–59), and section 144(f) of title 23, United States
- 23 Code, that has inactive funds or that has been completed
- 24 in the previous fiscal year. Such report shall include, for
- 25 each such project—

1	(1) the amount of funds authorized under such
2	section;
3	(2) the unobligated balance of such funds; and
4	(3) a reference to the public law, section num-
5	ber, and project number under which such project
6	was authorized.
